## **State Senior Ranking Policy**

1. South Australians with World Rankings in the Top 100 for Men and the Top 75 for Women will be automatically included in Squash SA State Rankings.
2. South Australian players residing anywhere in Australia who are AIS scholarship holders will be allocated a South Australian ranking.
3. South Australian players based in South Australia, not playing pennant but committed to playing professional Tournaments in Australia will be considered for Ranking.
4. The Matrix Rankings will be used as a guideline and for reference of results. Other factors that may be considered in rankings include but not limited to: time away from competition, injuries as well as head to head results.
5. Only local players who have played a minimum of 4 Pennant fixtures or matches in South Australian tournaments against other South Australian players in the Ranking period of 6 months will be considered for Ranking.
6. The Rankings will be as at January 1 and July 1 of each year.
7. Squash SA Staff will make recommendations to the Senior Coordination Advisory Committee. The SCAC will then approve the Rankings and inform the Squash SA Board for ratification.
8. All Senior State Rankings need to be ratified by the Board prior to being released.
9. Senior Rankings will be on the Squash SA website by February 1 (January Rankings) and August 1 (July Rankings) and players have the right to appeal their ranking to the Senior Coordination Advisory Committee in writing within 28 days of the ranking being published.
10. Further subsequent appeal to the Squash SA Board can be made, where decision reached is final.

### **Appeals administration fee**

11. An administration fee of \$50 will be charged for an appeal against the initial ranking. All or part of the fee will be reimbursed if the Squash SA Board finds for the appellant.
