- Same Motion as in March 2015 – with the addition of
- Affiliation Fees payable in 2016 shall be no more than 5% higher than Affiliation Fees paid on average in 2013 / 4 / 5; and no more than 10% in 2017.
- A supporting schedule was sent to all the states and territories illustrating the approximate affiliation fees, Matrix and Insurance fees paid in 2013 / 2014 / 2015; the average of the three years in total; and the maximum Affiliation Fee payable for 2016 [+5%] and 2017 [+10%]
- The purpose of this amendment was to provide confidence to the States and Territories that there would not be any significant increase in Affiliation Fees over this period. [Think of the \$80,000 debate in 2013].
