LOCATION: Basingstoke is a major centre for commerce and industry with a borough population of approximately 150,000. The Town is 45 miles to the south west of London adjacent to Junctions 6 & 7 of the M3 Motorway. There is also a frequent rail service to London Waterloo, timetabled at 45 minutes.

Unit D Prisma Park is located at Berrington Way, just off Wade Road. It is therefore easily accessible to both the Chineham Shopping Centre, and also to the Ring Road and therefore junction 6 of the M3. There is also a regular bus service to the town centre.

DESCRIPTION: The property comprises a high profile steel clad end of terrace unit. It is divided to provide an office at ground floor with a mezzanine above. It benefits from LED lighting in the warehouse, and a full height loading door. There are 4 car spaces to the front of the unit.
