Location

Guildford has excellent communications links being positioned 27 miles South West of London on the A3 midway between the Capital and Portsmouth. The property is located 2.5 miles South of Guildford town centre in a mixed commercial and residential area adjacent to Lookers Skoda and Volkswagen LCV and adjoining the Riverway Industrial Estate at Peasmarsh next to the A3100 Guildford to Godalming Road. Harley Davidson are located closeby together with a Shell petrol filling station, offices, and a Sunrise Assisted Living retirement home. Guildford is the nearest railway station with a journey time to London Waterloo of 34 minutes.

Description

The property is a modern purpose built car dealership comprising 6 car showroom, 10 bay workshop and MOT area, parts storage area, offices, and further first floor offices and amenity areas. The showroom is fully glazed to the front and one return elevation and elsewhere exterior metal cladding on the walls. There are also external parking and vehicle display areas.
