LOCATION

Salisbury is an historic Cathedral City in Central Southern England. It has a resident population of 40,302 approximately and a Salisbury District population of 117,500 (Source: 2011 Census).

Rail communications are provided by a main-line Station with frequent service to London (Waterloo) (90 minutes approx.). Road communications are well served to London via A303 (M3) (88 miles); Southampton via A36 (M27) (24 miles); Bristol via A36 (54 miles); Exeter via A303 (91 miles) (Source: The AA).

SITUATION

The Portway Business Centre is situated on the Castlegate Business Park at Old Sarum approximately 1.5 miles north of Salisbury. The A303 lies approximately 9 miles to the north at Amesbury.

Access is provided by a roundabout off The Portway, which links to the A345 Salisbury to Amesbury road.

DESCRIPTION

The property comprises a mid terrace factory/warehouse unit steel portal frame construction with part cavity brick and blockwork and part profile steel walls and roof. The unit is serviced by an up and over shutter door, has a fitted office, cloakroom facilities and a minimum eaves height of 12' 11" (3.94 m). The unit has designated parking and loading areas.




