The property forms part of the Wickenby Airfield situated off the Snelland to Holton-cum-Beckering Road about 1/3 of a mile north of the B139 which connects the A158 trunk road at Bullington, east of Langworth. The site has good links to the City of Lincoln and is about 19 miles from the Lincoln Ring Road.

### Description

The property is an open unit which provides good open space ideal for storage with loading through a roller shutter door at the front of the building. It has good eaves height of 5.82m and the unit has a roller shutter doors which is 5.50m wide by 6.13m high. 
