EQUIPMENT RENTAL AGREEMENT LIABILITY RELEASE AND EXPRESS ASSUMPTION OF RISK

THIS AGREEMENT is entered into between NSW Squash Limited (Sports Association)

This AGREEMENT is a release of the RENTOR'S rights to sue for injuries or death or any loss resulting from the rental and/or use of this equipment. RENTOR expressly assumes all risks related in any way to the rental and/or use of the equipment.

RENTOR hereby acknowledges receipt of the equipment designated in this form, and, if of this equipment is to be used for squash instruction, that RENTOR is a certified squash coach or coaching candidate in a recognised Squash Australia course/program under the supervision of a certified squash presenter/assessor.

RENTOR acknowledges that the equipment is in good working condition and that he/she has examined the equipment to ensure that it is free from defects, including checking the quality and quantity of squash equipment rented.

RENTOR also understands that NSW Squash Limited (Sports Association) And its employees, owners, officers, or agents (hereinafter "Released Parties"), shall not be held liable or responsible in any way for any injury, death or other damages to RENTOR or his family, heirs, or assigns which may occur as a result of the rental and/or use of the equipment, or as a result of product defect, or negligence of any party, including Released, whether passive or active.

RENTOR agrees to reimburse NSW Squash Limited (Sports Association) for the loss or breakage of any and all equipment at the current replacement value and to also pay for damages incurred while transporting the equipment.

RENTOR agrees to return the equipment at their own cost in clean condition and to pay a cleaning fee if not returned cleaned.

I understand the terms herein are contractual and a mere recital and that I have signed this document of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.
