3. CONFIRMATION OF MINUTES OF PREVIOUS MEETING

It was moved Greg Ward, seconded Nathan Ward "that the minutes of the meeting held on Saturday 20th April, 2013 be confirmed.

4. BUSINESS ARISING FROM THE MINUTES

The list of outstanding items from previous meetings with comments from today's meeting follows:

7. GENERAL BUSINESS

7.1 STPP Manual

After some discussion it was moved Chris Doig and Seconded Leon Barnett;

"That the report from the President of Squash Tasmania on the Squash Tasmania Performance Pathway Policy Document be received and that:

- 1. The Squash Tasmania Performance Pathway Policy Document, Version 2 be formally approved by the Squash Tasmania Committee, and
- 2. The Squash Tasmania Performance Pathway Policy Document, Version 2 be posted on the Squash Tasmania Page of the Squash Australia Website."

7.2 Squash-in-Schools

Leon Barnett's report was discussed. Chris Doig explained the process of grant application and delivery of the program. Squash Tasmania's State Grant application is submitted before the end of August and 100% of the grant 2013 grant was for the Squash-in-School Program. We are usually notified of our grant allocation by the end of November. The person or company delivering the program is confirmed shortly afterwards. As agreed previously expressions of interest for the delivery of the Squash-in-School prior to 2014 calendar year.

It was agreed that Squash-in-Schools would be the focus of our grant application for 2014 and the process of delivery would be further investigated and reported on by a committee working group.

It was moved Leon Barnett and Seconded Kent Harbutt

"that a a working group comprising of Leon Barnett, Greg Ward and Chris Doig review the method of appointment of a contractor to deliver the Squash-in-Schools in 2014 and report to the next meeting recommending a process to be followed."

7.3 Tasmanian Junior Classified Events Tournament Director

Leon Barnett's report was discussed in conjunction with the Chairman of the STPP Junior Committee's request for a review of the regulations for running Gold, Silver and Bronze Australian Squash Tour Events.

It was moved Leon Barnett and Seconded Greg Ward

"that a recommendation be sort from the STPP Junior Committee on the regulations under which Australian Squash Tour Events held in Tasmania be conducted."

Carried unanimously

7.4 2013 Tasmanian Open

It was moved Leon Barnett and Seconded Greg Ward

"that the Report from the Tasmanian Squash Academy on the 2013 Tasmanian Open be received and that:

- 1. The balance of the prize money guarantee for the 2011 of \$3,000 set aside to guarantee prize money for the 2012 Tasmanian Open be brought forward to the 2013 event.
- 2. A further \$2,000 be set aside to guarantee prize money for the 2013 event.
- 3. The actual expenditure on the Tasmanian Open will be decided at a future date."

7.5 Squash Tasmania Committee Roles

It was moved Chris Doig and Seconded Leon Barnett

"that the report from the President, Squash Tasmania on Squash Tasmania Committee Roles received and that:

- 1. The position descriptions be adopted as part of Squash Tasmania Policy and Regulations,
- 2. Brett McGrath be invited to fill the position of Secretary as defined,
- 3. A working group consisting of Kent Harbutt, Michael Brown and Chris Doig be set up to review the voluntary position of Development Manager and to provide a report on the process of making an appointment."

8. OTHER BUSINESS

8.1 Tasmanian Junior Open

Greg Ward asked for a briefing on the 2013 Tasmanian Junior Open progress. Leon Barnett and Chris Doig provided an update.

8.2 Ian Hocking Medal

Greg Ward asked what progress had been made towards calling for nominations for the lan Hocking Medal. Kent Harbutt advised that the medal would be presented at the Tasmanian Squash Dinner in November.

8.3 Secretary's Position

Leon Barnett asked how quickly the Secretary's position could be filled. Kent Harbutt advised that this could be done prior to the next meeting.

8.4 PSCAA/NCAS Matters

Leon Barnett asked for clarification on insurance and coaching accreditation. Chris Doig advised that coaches that are registered with Squash Tasmania and working in an official Squash Tasmania Program or program of an affiliated body are insured through Squash Australia's policy. For coaches working outside this framework the PSCAA membership includes coaches insurance.

8.5 Website Updating

Chris Doig asked Nathan Ward to approach Michael Brown with a view to Nathan taking on a more senior role in updating the Squash Tasmania webpages.
