Item 2 – (David Mandel) PSCAA – motion at the last AGM

- a. I ensured that a copy of the motion was sent to the President and all board members of the PSCAA, and received confirmation from them that it was received.
- In response to an email I sent to Esdon Lee, President PSCAA earlier this week, I received the following reply.

Item 3 – (Sue Shearer) PSCAA Acknowledgement

a. Sue acknowledged the work done with the PSCAA by the Board.

6 Annual Report.

The 2015 Squash Australia Annual Report be considered.

President's Report be approved.

Sue Shearer Moved, Sam Abishara Seconded, Carried unanimously.

CEO's Report be approved.

Peta Murphy Moved, Ros Preston Seconded, Carried Unanimously.

7 Financial Report.

David Mandel made a number of comments about the Financial Report to aid in its understanding. The first comment was that when looking at the Profit/Surplus for the period this has been created by the change in Fiscal years and that this period is only a ½ year when there is historically lower expenditure. He also noted that due to staff vacancies, there was significant underspending in the period, and spending on Grants deferred into the next year. The next comment related to the new Annexure included on Page 5 of the Audited Financials which was an innovation intended to illustrate the financial flow between the National Body and the States.

The comment from David on the Annexure created a number of questions from some of the Members and they had a number of questions as follows:

- a. Question from Sam Abishara was the Annexure a part of the Audit. Answer from David Mandel It was a part of the audit.
- b. Question from Dawn Moggach regarding the amounts in the Annexure were not a true reflection. The amounts listed were not received by NSW Squash and this is misleading. Answer from David Mandel These were the funds invested in the State, and not necessarily in the State body itself. This was the first time this document had been included and there will need to be a review of how the document is presented in the future.
- c. Question from Roslyn Preston regarding the amounts for Q Squash. Answer from David Mandel The document will be reviewed for use in the future.
- d. Question from Mike Cornish in regards to the above questions. Answer from David Mandel this is the first time the document has been used and it will be reviewed for future use.
- e. Question from Dawn Moggach on how can the Financial Report be approved with the Annexure not representing accurate information for NSW Squash. Answer from Bob McComas The motion for approval of the Financial report to be noted that some of the figures received under NSW Squash were for PSA Tour events for Clubs/Centres in NSW and that NSW Squash did not receive this funding

Motion - The 2015 Squash Australia Finance Report be approved including the notation that NSW Squash did not receive some of the funding for the PSA Tour recorded in the Annexure on Page 5 of the audited financials.

Peta Murphy Moved, Bob McComas Seconded, Q Squash against, Carried by the majority.

Squash Australia will not raise these fees for the next two years (calendar 2016 and 2017) except for inflation, and will cap the affiliation fees payable by each state and territory to the average of their fees paid in calendar 2013, 2014 & 2015 plus 5% in 2016 and plus 10% in 2017 irrespective of actual numbers of players registered.

Those Members that wanted a single rate for affiliation (i.e. not have a Urban / rural split) could do so, at the average, and those that wanted a larger subsidy for rural could also be accommodated.

Moved the Board:

Bob McComas had questions on the subscriptions and that the document had changed and he would need to go back his Board before he could vote on it.

From the Vote, Squash Tasmania, Squash and Racquetball Victoria and Squash NT voted for the above subscriptions with all other members voting against the proposal, less Squash ACT whom abstained from voting. Therefore, the Motion was denied.

All Members were asked why they had voted the way they had. Squash and Racquetball Victoria and Squash NT were disappointed with the proposal being rejected. The Squash Australia Board was also disappointed with the result, having discussed this proposal with the members a number of times over the previous 12 months including at the March 2015 AGM. As two of the Members had to go back to their Boards for further discussion the following decision was agreed upon.

All Members were to have discussion with their Boards on the above proposal and advise Squash Australia by 15 November if their decision had changed to accept the proposal. Squash Australia is prepared to hold an Extraordinary AGM before Christmas 2015 if the discussions with the Members have changed their stance on the proposal.

9 Election of Directors.

David Mandel advised the members that there were 3 vacancies on the Board and that 3 nominations were received. Therefore, David announced that Marcus Smith, Dale Robbins and himself were elected onto the Board of Directors.

10 Notice of Motion.

Motions received in accordance with the Squash Australia Articles of Association due 5:00pm 25th September 2015:

- a. To amend paragraph 10.4 of the articles of association of Squash Australia Ltd by adding another sentence as follows:
 - 10.4. Save for the exception set out in article 10.7 hereof, the term of office each elected Director shall be two (2) years, with three (3) Directors elected one year and the other two (2) Directors elected the following year. The term of office for each appointed Director shall be the same as for each elected Director.

Moved The Board, Seconded Sue Shearer, Carried Unanimously

b. To amend Paragraph 10.7 of the Articles of association of Squash Australia Ltd by adding another sentence as follows:

10.7. At the Annual General Meeting of the Company in each year, all Directors who have completed their term of office for the time being shall retire from office but shall be eligible for re-election upon nomination. Save that no Director, elected or appointed, may serve more than ten years in any consecutive thirteen year period.

Moved The Board, Seconded Sam Abishara, Carried Unanimously

11 Appointment of Patron.

No motion received.

12 Appointment of Auditor

The Chairman put the motion:

Integrated Audit Service Pty Ltd be appointed as Auditor of Squash Australia for 2015/16.

Moved the Board, Seconded Roslyn Preston, The Motion was passed without dissent.

13 Other Business - as approved by President

- a. Peta Murphy noted that she felt the weekend had been positive and more productive than previous years.
- b. David Mandel thanked all for their attendance.

14 Meeting Closure

The President closed the meeting at 13:33pm.
