ANNUAL REPORT BY THE CHAIRMAN OF THE BOARD OF TENNIS SOUTH AFRICA FOR THE PERIOD 2015/2016

1 GENERAL OVERVIEW

This Report is presented at the conclusion of a challenging year for the national Tennis Federation.

That said there are many positive achievements over the past year – we continue to create a positive environment for junior and senior tennis, have achieved our Silver Status Coaching Accreditation from the International Tennis Federation and continue to have a number of our technical officials represent our country in major overseas tournaments. In addition a number of your administrators have represented the country with distinction on various International Tennis Federation Committees thus ensuring that we remain a well-respected tennis nation in the world community.

We need to acknowledge our disappointments. We have not received any National Lottery Fund grant this past year and we continue not to have a sustainable long term business model for our sport. These result in us being severely limited in what we are able to offer tennis players in South Africa — with our focus being to retain a staff that provides a basic enabling environment for assisting with the organizing of events, a coaching system and dealing with the ever increasing demands of government for information and implementation of political policies.

At the conclusion of a year we should pause and reflect on our Vision, Mission and Values:-

Vision:-

"We all see someone playing tennis, somewhere, every day"

Mission:-

"To enhance the quality of life for all South Africans of any age group, by growing the sport of tennis at every level, for everyone who wants to become involved"

Values:

"Transparency, Personal Accountability, Sportsmanship"

Tennis South Africa is committed to these and we believe every decision we make has as its foundation these three core components.

2 STAFFING AND OFFICE PROCESS

The office remains situated at the Lords Office Park in Centurion. Our lease of these premises expires in May 2018.

Our review of office processes and responsibilities remains ongoing. Both Clark Coetzee (Board Member) and Rob van der Schyff (HR and Strategy Consultant) have spent a considerable amount of time and effort interacting with staff collectively and individually so as to streamline office processes, particularly with regard to the whole tournament cycle process.

During the course of the past year we took the decision to end the Reward Card offering to our membership and to also move from the Tournament Manager software to the Sporty HQ software. It is fair to say that both the cessation and move have not been without their challenges, in the first instance resulting in considerable confusion amongst our membership as to where and how to pay their annual Registration Fees and secondly the new Sporty HQ information technology has required considerable additional adaptation and development (not to be unexpected) than originally thought. This has caused a number of challenges, particularly from within the Seniors Division of our organization. However can I say that Sporty HQ have tackled the numerous challenges with gusto and dealt with queries and issues timeously. Our particular thanks to Clark Coetzee for leading and managing this process and ongoing implementation.

Last year we reported that it was with some frustration that we were falling behind in terms of staff remuneration levels. A review of remuneration levels was undertaken by Rob van der Schyff and the general analysis showed that we were, on average, some thirty percent behind comparable commercial levels. The Board took the decision to adjust staff remuneration – unfortunately not by the full recommendations – by on average ten percent in May 2016.

During the year under Mninawa Ndaku, who had been serving an internship with our office, was appointed on a full-time basis. Lorraine Cruickshanks (our bookkeeper) and Venessa Kiley (secretary) resigned effective January and March 2016 respectively. The Board took the decision to upgrade the bookkeeper position to that of Financial Manager/Office Administrator. An employment agency was appointed to recruit such a person and we welcomed Ridhwaan Dawood into the office on the 1 February 2016 – a decision that is bearing fruit.

With the guidance and assistance of Rob van der Schyff we have commenced a process of engaging with staff individually every six months with the purpose of listening to their challenges and suggestions regarding how we can, not only improve the working environment, assist in upskilling them so as to add further value to them and our business. This process, I believe has been well received and is an important component in keeping staff motivated and feeling needed.

The process of looking for a new Chief Executive Officer has also been ongoing. Considerable effort and time, with the aid of an Executive Recruitment Agency, was expended over the past year is seeking the right person. This has now culminated in the appointment of Mr Richard Glover as Tennis South Africa's Chief Executive Officer with effect from 1 October 2016. We would like to thank everyone involved in this process and final appointment.

We reported last year that Iain Smith had not been well and that he had been recovering. I am pleased to say that he is now recovered. Mpho Makhoba has not been well and her health is being carefully monitored. Tennis South Africa remains committed to being an employer who cares about its employees and we firmly believe that staff is Tennis South Africa's main asset.

We need to acknowledge that we have an extremely loyal, passionate and hardworking staff. Few people know the number of hours that are worked without recognition or compensation by them. We thank each one of them and assure them of all our appreciation for what they do.

3 GAME SET AND MATCH – TSA STREAMING PROGRAMME



Game Set and Match, whilst a Tennis South Africa (TSA) asset and an attempt to try to enhance local tennis in terms of a weekly talk show, unfortunately did not grow to the expectation of both TSA and the GSM Streaming Team.

TSA Manco met with the GSM team in September 2015 to discuss the way forward. GSM was given a six (6) month window period in which TSA provided capital to support the show, with the understanding that GSM would be self- sustainable by end of March 2016.

The GSM show was reduced from 30 minute shows to 8 minute weekly shows in order to try and encourage greater viewership by reducing time on streaming.

This unfortunately did not grow the viewer base in terms of the weekly show. During a meeting with the TSA Social Media Company (Calidascope) the GSM show was discussed and the following conclusions were drawn based on the numbers presented:

- Content was possibly not correct
- Cost of streaming and data
- Target market

Calidascope did however indicate that the GSM programme was a good initiative and that the timing of having such a programme at this stage was possibly premature and that this was a project to be relooked at for the future.

Calidascope also did present that while Streamit 360 (platform for GSM) handled the streaming component of the Davis Cup tie – South Africa vs. Luxembourg, that is was interesting to note that a total of 12,000 views were logged for the tie, which indicated that Live Tennis was probably more of an attraction to the GSM weekly show.

TSA informed GSM that TSA was no longer in a position to fund or provide funding for the programme, but, should Streamit 360 wish to continue with the GSM programme at their cost then TSA would support this.

TSA would like to express our sincere appreciation to the GSM Team for the efforts in putting the programme together:

Everyone involved in this project did this with passion and belief in the product and programme, often with no or little costs involved and a production that was put together on a budget well below market value.

4 DISCIPLINE

An unfortunate incident involving a racist comment took place in February 2016 during the Gauteng North Mini 1 tournament which took place at Groenkloof Tennis Stadium.

A TSA Disciplinary Committee was convened to handle the hearing. Upon conclusion of the hearing, the parent involved was awarded a Life Time ban from attending any sanctioned tennis events. The parent has subsequently appealed the decision and the Appeals Committee under the chairmanship of Advocate J Vorster reduced this ban to one year.

TSA abhors any form of racism and is fully committed to the eradication of this crime.

The non-payment code violation was re-assessed and the decision taken was that entry fees are payable upon entry. While this did take time for parents and those handling the entries to become familiar with, it has reduced the administration load in the office significantly in terms of following up on missing payments.

5 OFFICIATING





TSA's Officiating Programme continued to make positive strides during the past year. The limited number of International events does continue to put the ITF certified officials under strain in terms of maintaining their qualifications. The addition of the Stellenbosch Futures in November did prove to be a major boost for the ITF officials and local officials.

ITF LEVEL 2 SCHOOL:

TSA applied to the ITF to host a Level 2 White Badge School during the Stellenbosch Futures. The application was successful and the school took place during the second week. A total of seventeen (17) candidates from Africa was accepted to the school, five (5) of which were from South Africa.

The school was taught by Soeren Friemel (ITF Head of Officiating), Pascal Maria (ITF Grand Slam Official) and Iain Smith (ITF Officiating Officer).

The South African candidates that passed the school were:

- Tebogo Maleke (GC) ITF White Badge Chair Umpire
- Patrick Selepe (GC) ITF White Badge Chair Umpire
- Adri du Plessis (GN) ITF White Badge Chief of Umpires

Patrick Selepe became the first official from wheelchair tennis (with a disability) to become a certified ITF official.

TSA's total quota of White Badge Officials increased to twelve (12) officials, covering qualifications as Chair Umpires, Referee's and Chief of Umpires.

ITF LEVEL 3 SCHOOL:

The African five (5) year Officiating Plan included a Level 3 school to take place in 2015 in North Africa. South Africa nominated three (3) candidates to be considered for an International Certification. The Level 3 School forms part of the joint Officiating Programme between ITF, ATP and WTA.

Mpho Makhoba (GN), Mxolisi Matyolo (GE) and George Phiri (GN) were nominated and accepted to attend the school on Morocco. The school was held from 18 to 22 October and taught by various full time officials from ITF, ATP and WTA.

TSA can feel proud of the results achieved as two (2) of the three (3) candidates passed and achieved the following International Certifications:

The above success sees South Africa's International Officials grow to four (4) officials, namely:

The second tie of the year, was played at Irene Country Club. The Home Tie provided an opportunity for local ITF certified officials to be assigned as Chair Umpires to the tie.

<u>Davis Cup – March 2016 (South Africa vs. Lexembourg):</u>

The first round of the 2016 competition was played at Irene Country Club. As always, home ties provide an opportunity for local ITF officials to be assigned to work at the event.

The officials assigned to the tie were:

This was Mpho Makhoba's first assignment as an International Chief of Umpires. In both of the above events, South Africa received good comments from the Referee in terms of the quality of the local officials, both Chair Umpires and Line Umpires.

Mpho Makhoba was also awarded the Official of the Year award by Gauteng Government during the time of the hosting of the tie against Luxembourg. Gavin Crookes also made a special award on court to Mpho on the Saturday, prior to the commencement of the doubles tie.

ITF Futures:

While the hosting of Futures events provides good opportunity for local players to test and enhance their skills, the same applies to local officials and the officiating programme.

The officiating programme is two tiered in that the current certified officials need to officiate a minimum number of matches to maintain their certifications with the ITF on an annual basis and the up and coming National officials need match practice to be able to gain the experience to attend and pass an ITF school.

The events at Stellenbosch did just that as during the three (3) weeks, TSA was able to rotate fifteen (15) officials (ITF and National) on a weekly basis to ensure that all officials were able to benefit from the rotation system. IN addition, the National Officials assigned to the events were those selected to attend the ITF Level 2 School and this provided an opportunity to conduct additional training and preparation of the officials.

6 JUNIORS





JUNIOR MEETING AND RULE AMENDMENTS

The Junior meeting took place in an electronic form during November 2015, with an undertaking for a official meeting to be held in 2016.

Initially the attendance of the workshop posed a challenge and the meeting was reconvened due to technical difficulties experienced.

MINUTES OF THE SPECIAL GENERAL MEETING HELD VIA TELECONFERENCE ON 21st NOVEMBER 2015 09H00.

1. Welcome:

Riad Davids (RD) welcomed all on the conference and thanked everyone for being available. Discussed the importance and reason for reconvening the meeting, in order to ensure that all stakeholders were awarded the opportunity to be part of the decision making process due to IT issues experienced the previous week.

2. Confirmation of process to be followed:

Tony Louscher (WP) raised the concern about the tele-conference being able to make tough and important decisions. The matter of proxies being valid was also discussed and the meeting agreed that proxies would not be considered as the proxies were not present to consider debates and to reconsider their original vote.

The meeting all agreed to the proposed way of conducting the meeting.

3. Apologies:

Apologies received were:

Gauteng Central Northern Cape North West Province Mpumalanga

4. <u>Delegates announce their attendance when called to do so and confirm accreditation by</u> registering the name of the accrediting officer:

RD went through the list to confirm attendance and that the delegates had the accreditation from the respective Provincial President to attend and vote at this meeting.

5. Quorum confirmed/meeting rescheduled:

RD confirmed that there was a quorum and that the meeting could proceed with the review of the rule changes proposed.

6. Items on the rules that need further debate:

a. AGE GROUPS:

Although the age group aspect was not on the previous weeks agenda, RD raised the aspect due to the fact that this matter was raised during the 14 November teleconference.

RD explained that even though the TSA Board had taken a decision, that the President, Mr. Gavin Crookes has indicated that f the meeting were of the opinion that this should be reconsidered, the Board would look at this.

Following various points raised both for and against the age group change the meeting resolved that the age group change would remain as per the decision taken by the TSA Board.

<u>Decision Taken:</u> Age groups to be u10, u12, u14, u16 & u18. Age groups to be determined based on age on 1 January annually.

b. TOUNAMENT FORMAT FOR TSA EVENTS:

RD gave WP and Boland the opportunity to discuss the Feed-in system vs. Monrad. The matter was debated, with various responses received. Boland made presentation that the Feed-in system favoured the rural provinces, with support shown from Eden. Gauteng North agreed with the statement that entries had dropped based on the format change and Free State indicated they were in favour of the Monrad based on their opinion being that the feed-in was not fair on scheduling and Monrad provided players with more balanced matches.

The initial round of voting, excluded TSA Board Member and staff had a stale mate of 4 / 4 in favour of Monrad and Feed-in. RD called Eastern Province representative who had excused himself and it was confirmed that EP committee were also split and could not resolve the matter amongst themselves.

The meeting agreed that RD as the TSA Board Member and Chairperson of the meeting should have the casting vote. RD explained that based on the facts his personal vote was to go in favour of the Feed-in system.

It was agreed that due to correspondence having already gone to the public and tournament entries having been opened that the Monrad would remain as the TSA Series format from 1 December 2015 to 30 November 2016 and that effective 1 December 2016, the format would revert back to Feed-in. This was accepted by all.

<u>Decision Taken:</u> Monrad Format to be used from 1 December 2015 until 30 November 2016. All positions to be played off i.e. 1 to 32. Quarter-final and semi-final round losers to play off to final positions.

c. **DOUBLES PLAY-OFF MATCH:**

The meeting was in agreement that the doubles play-off match be done away with.

Decision Taken: Only Doubles Main Draw, no additional Play-Off match

d. **GUARANTEED STRENGTHS:**

The aspect on guaranteed strengths was discussed along with the motivation for amending the points tables for TSA Series events carry more points that ITF Grade 4 and 5 events.

IS reminded the meeting that the 2014 Workshop and as stated in the minutes the various aspects were agreed and decided upon when Guaranteed Strengths were to be re-introduced. The majority support the proposed changes.

WP raised the concern of Playing out of age group and "buying free points". It was noted that while the 2014 rule change was for 64 draws that the rule be revisited where players playing out of age group earn actual age group points or points relative to the age group playing in at the tournament. The Committee were reminded that the guaranteed strengths would be the same or higher that TF's. IS proposed that the rule be kept simple and that if a player wins 2 rounds in the respective draw then they are awarded the age group points in which they are competing, if not able to win 2 rounds in Main Draw then player is awarded points based on his/her actual age group. The meeting agreed to this proposal.

<u>Decision Taken:</u> Guaranteed Strengths to be re-introduced. 32 Draw, player to reach Quarter-Finals, 16 Draw, player to reach semi-finals and 8 draw, player to reach final if playing out of age group to be awarded the actual points.

Boland raised the issue that the tournaments counting toward ranking had been changed from 6 to 4 the previous week (14 November). This was debated with Free State stating their reason for the 4 tournaments to count rather than 6. Mention was made that this is a National ranking and not a Regional or Provincial ranking.

The Provinces voted and the majority were in favour of going back to 6 tournaments to count as per the original document.

<u>Decision Taken</u>: Best 6 results will count for ranking purposes. Only a players best 3 ITF results will count. Rankings released in January following the results from the GN TSA Series event will display the Guaranteed Strengths from all tournament TSA Series events being played in December. GN acceptances will be based on the rankings in December which are still on actual strength in order to fall in line with the acceptance procedures for the December TSA Series events.

e. **PLAY-OFF MATCHES**

The meeting was in agreement with the fact that Play-Off matches to be mandatory, with the exception being where a player submits an official medical certificate from the appointed tournament Dr or medical clinic.

Where an official medical certificate is not produced, the player will not be awarded points for the position reached.

<u>Decision Taken:</u> Play-Off matches to all positions are Mandatory. Only medical certificates from the appointed tournament doctor or clinic will be accepted.

f. **DOUBLES/MIXED DOUBLES ACCEPTANCES & SECTIONS:**

Reasons for the proposed change were discussed, with main emphasis being to enable players to decide who they want to play with, rather than being "forced" based on singles event i.e. Platinum, Gold or Silver.

The point of careful scheduling was mentioned as the situation of a players, playing at two different venues can occur based on venue sizes. It was highlighted that tournament directors would need to manage scheduling carefully. The meeting took note of this.

<u>Decision Taken:</u> Doubles acceptance to be based on combined singles rankings, seeding to be based on doubles ranking. But, players from Platinum and Gold can play together. Doubles draws to remain at 16 Draws.

Mixed Doubles to be based on players in a certain section (Platinum to play with Platinum or Gold with Gold). Mixed doubles acceptances will not allow players from Gold to play with player in Platinum.

1st round of mixed doubles to be played on Day 1 as it is a 32 Draw, with Doubles only commencing on Day 2.

Players also commit for the full duration of the tournament and play-off matches will not be scheduled to be played earlier, to accommodate players i.e. semifinal round losers to play same day.

7. Closing

RD went through the decisions taken in summary and again asked for affirmation of these decisions and the Committee agreed.

RD thanked all for their time and input.

The meeting was adjourned at 11:45.



LOCAL TOURNAMENTS

The local tournaments in most cases were well run by the respective Provinces and appointed tournament organizers. Most of the organizers are ofay with the tournament rules and system that is being used across the country and this has assisted in ensuring that tournaments are run in a standardized manner with very few errors being made in terms of draws etc. However, in terms of rules and procedures there are revised on an annual basis in order to ensure that the entry procedures, code of conduct and basic formats are in line with what TSA strives to achieve on the local front, in consultation with the various junior chairpersons from around the country at the Junior Workshop.

Looking at the past year the total number of entries received and managed by the online system were as follows:

March 2015

The tournament took place from 27 – 30 March. All 14 TSA Provinces attended with Gauteng North hosting a B side with the Under 15 age group and Gauteng Central hosting a B side with the Under 19 age group. Zimbabwe made up the 16th team in both age groups. The following venues were used: Elardus Park, Irene, Groenkloof (12 courts), Tukkies (12 courts), Afrikaanse Hoër Seunskool, Uitspan, Pretoria High School for Boys, Pretoria High School for Girls, Rietondale, Belgrave, Brooklyn Union, Menlo-Alkant, Lynnwood and Waverley Tennis Clubs.

The teams were divided into four groups of four according to the combined rankings of the players. This method proved itself in the past and again this year as the top 8 ranked teams ended up in the so called A section playing for positions 1-8. Gauteng North and Gauteng Central battled it out in both age groups with Gauteng Central defending the title that they won in 2014.

Our gratitude to Clark Coetzee (president Gauteng and Gauteng North tennis) for the team managers and coaches' function. We were also fortunate that Gavin Crookes could attend. Both gentlemen appearance at the courts as well as other board members like Riad Davids showed their commitment and interest in junior tennis.

No incidents on or off the courts were reported. The high light was the announcement of the SA Schools team. This was also received favourably.

We stayed within the budget. As agreed he excess will go to the 3 age groups travelling abroad. The Primary Schools will travel to America and also attend the US Open. The two high schools age groups will tour the UK and attend Wimbledon.

The bid for the next year needs to be done immediately. A proper schools week needs 12 months of planning. The requisite is simple:

- The Primary Schools need 8 venues of 6 courts each with no netball lines within close proximity of affordable accommodation.
- The High Schools need 16 venues of 6 courts each with no netball lines within close proximity of affordable accommodation.

It is also important that the board approve the date for the event ASAP.

General comments:

- It is very important that the president from each province must familiarize him/her with the system in his province with which the provincial team is selected.
- The president of the province must assure that a proper AGM takes place. The notice for the AGM must be send to as many as possible. It must be on the provinces web site.
- Team selection has to be an important point at every AGM.
- Decisions taken have to be send to all involved. TSA has to receive a copy. The rules for team
 selection must be available on the provinces web. Try not to change the format every year.
 Rather refine what you have and learn from mistakes in the past. Do not allow individuals to
 take decisions. Remember any decisions taken at an AGM can only be changed at the next
 AGM. Consistency brings trust.
- Provinces have to make sure that a proper development program is in place. Too often teams
 realizes at a very late stage that there are very few or sometimes even none PDI players to
 select from. We are committed to development. No development no participation.
- Provinces must put a financial plan in place to make the Schools week an affordable one. TSA
 has been able to subsidize the event thus far. We are grateful but have to strive towards selfsustainability. Provinces can host min-series, championships, add a small add on to league
 fees etc. to support the provincial team.

June 2015

We were also fortunate to be successful with all visa applications – something that did not always happened in the past.

For the first time we will have an official capping ceremony at the Premier Hotel prior to departure. Our sincere gratitude to Gavin who initiated this as well as the Under 18 players that will travel in smart casual with blazers. This has come to stay. We have parents flying up from Cape Town to attend.

Our matches against a Scottish junior Invitational side has been confirmed as well as the matches against the Sutton Academy. With the help of TSA every player will have the advantage of a Court ticket at Wimbledon, without doubt the high light of the tour.

25 June 2015 - 5 July 2015

On 25 June 2015, 19 very excited players arrived at the Premier Hotel for the capping ceremony before taking off to Edinburgh. The capping ceremony was a first for schools tennis initiated by Mr Gavin Crookes. The Under 19 players were issued a smart formal jacket with the TSA Schools badge embroidered. The junior players received their SA Schools jacket. A professional photographer took the team photo. Mike Dunk and the BLD group were responsible for the media coverage and about 6 media groups were present. I suppose the coming up Davis Cup tie played a role. The fact of the matter is that it created excitement. It also enhanced the importance of the occasion.

Jenny and I nervously went to the airport as the new legislation about unabridged birth certificates just came into place. Armed with lots of paperwork we went through customs unharmed. The flight to Edinburgh via Heathrow went well. A cold and wet Edinburgh welcomed us on Friday 26 June. The day was spend discovering The Royal Mile and other interesting places. The bag pipes being played all over the city creates an atmosphere rarely matched.

He spend time after the match with the group and a team photo with Kevin became a memento of each player.

Tuesday 29 June was match day against Sutton, one of the junior sponsored LTA academies. The tie is being played on clay and we usually are doing very well. This year it was tight and at some stage we were 12 all in matches. Fortunately we managed to take 4 of the last 5 matches.

The rest of the tour was spend doing sightseeing and spending a second day at Wimbledon. A very tired but satisfied group returned to OR Tambo on 5 July.

General

It is worrying to hear that are people who want to do away with "provincial" tennis. We all agree that the setup has to adapt to the 9 provinces of the government but cutting provincial tennis will bring an end to schools' tennis. Tennis as a sport has 3 main competitors at school. Golf (without doubt our country's most successful code), hockey and cricket. All of these codes involves a "stick and a ball". It is a fact that a team sport is more popular than an individual sport, making hockey and cricket our main "enemies". Golf, cricket and hockey have provincial competitions. Hockey even make provision for so called A, B and C team competitions on provincial level. My school won the Pretoria under 15 tennis league 3 years ago. Two of those players made provincial hockey teams and this year only played tennis on a part time base. This is especially sad as it is their matric year.

I have always emphasized that our main purpose in schools is to grow numbers for the game. If we take opportunities like provincial and national colours away, we can say good bye to numbers. The Schools Week and the two International tours for Primary and High Schools are the high light on the tennis calendar. Replacing them with anything less will be suicide.

Last but not least thank you to TSA for providing us with a lot of support. Thank you to the office and all their help. Thank you to the parents for their support. Also to Jenny Koster for her huge input.

NOVEMBER 2015

Schools week 2016

The dates and venues for this prestigious events have been finalized. Bloemfontein will host the Primary Schools event and Pretoria the High Schools event. For the first time the events will follow Nationals. The rational is to have more spectators at the finals at Nationals. Time will tell if this is successful. The down side is that we will have less time organizing the overseas trip for the High Schools. If Nationals do not gain substantially from this change of events we would prefer that the Schools Week be hosted early.

TSA Website

The "Schools" sub title is a great add on. Valuable information is being added. Contact details for provinces, selection criteria for provincial teams, festival dates are just a few that will add value.

Registration

The registration for so called social members is still a frustration. At the previous board meeting we declared that 2016 will be a "No TSA number – No Participation" year. Some provinces already finalised league fixtures for early 2016. The social membership registration was (is still) not in place. This way we are not only losing revenue but also blocking a lot of other initiatives.

Inter district competition

It remain an objective from the Department of Education as well as Sport and Rec that the federation play a major role in getting an inter district competition of the ground. This will remain a huge challenge as the government expect information from the federation that is almost impossible to obtain. Each

district in the country has a district office. Each district office has someone appointed to sport. The district office have a list of all schools in that district. They (should) have numbers – learners and teachers, facilities available etc. at the office. Nonetheless they expect the federation to supply this data. I attended a Sport and Rec meeting where I was given the contact details of the Head Office in all the provinces. Two thirds of the mail sent to these offices came back. The addresses were wrong. I sent another mail to Sport and Rec asking for the correct addresses. My mail was unanswered.

I agree that the potential to grow the game lies developing tennis at all levels. The task at hand is to say the least a daunting one without more help from the department. To organise competitions and create systems will be an easy one if we know who to talk to.

International Schools Festival - Brazil 2017

I had the opportunity to attend a social event at the SASCOC headquarters with the ISF delegation. Having had the privilege to attend the ISF in Doha early this year, I was acquainted with Pam Burrage and her team. It was a more than useful exercise. I met the people being responsible for the 2017 event in Brazil. I obtained useful information regarding travel and accommodation.

The "Road to Brazil" will be up on the TSA website soon. An invitation went out to all schools in the country. An invitation will also be posted on the website. We attended this event for the first time this year. We did not have any time for a local competition. The teams (Grey College and Oranje Meisieskool) were selected on the mere fact that the combined ranking of the team members were the lowest. I would like a Board decision on the following:

- A sponsored National competition to select the teams for 2017.
- To "ring fence" R30 from every registered Junior for this purpose and to support the teams travelling.

The ISF is looking for a hosting country for 2019. I would like a Board decision on the following:

- Permission to get full information from the ISF of what is required.
- Investigate the possibility to host the event.

The numbers reflect a decline in registrations. Possible reasons include –

- Change back from the online TSA/LiveLife based registration system
- Not trusting the online payment options. This also led to quite a number of paper entries or just dumping fees into the TSA Coaches account known to coaches
- Introduction of CPE and resultant increase of fees by R500

PROVINCIAL COACHES COMMITTEES/ASSOCIATIONS

Very few provincial Coaches Committees/Associations function on a constitutional/regular basis. Willingness to serve a tennis cause outside of one's personal involvement in tennis together with a dramatic change lifestyle and social environment appear to be the major stumbling blocks. The limited income generated by provincial coach's fees also make it unlikely to offer the prospect of professionalizing the coach's provincial administration.

DONALD THOMSON

Donald Thomson vs TSA, KZN, DTA and Chiltern Park Sports Club after losing his case, applied to appeal the decision. A guarantee of R5000 was imposed before the appeal would be granted. On failing to deposit the guarantee after six months, the appeal application lapsed.

ITF WORLDWIDE COACHES CONFERENCE

The WWCC was held in Antalya Turkey, from 22-29 November 2015. 750 delegates from 99 Countries attended.

The official representatives at the conference were: Ms. Bridget Visee, Mr. Allan Karam and Mr. Leon Freimond, Thabo Mathlaela received an ITF Scholarship to attend. Bantu Nkangana from the Eastern Cape arranged funding from Eastern Cape Sport and Recreation. 3 other coaches namely: Paul Jones & Jean De Lange from Gauteng Central and Martin Redelinghuys attended.

Three South African presented namely: Board Member Allan Karam, Riaan Kruger (ITF Development Officer) and Kirsty Elliott (UP Sport Scientist). Jean and Martin were asked to act as hitters in the drill sessions on day one. This snowballed and in the end they were used in almost all the presentations and represented South Africa very well.

The main features of the presentations, especially the on-court presentations, centred around strategy and tactics. The main points made were:

- Playing close to or inside the baseline.
- Try to avoid giving up that position as seldom as possible.
- Improving both linear and lateral movements.
- Taking time away from the opponent.
- Open technique based on situation rather than one formal technique for all situations.

The ITF Coaches Commission also met at the WWCC. Main developments that were announced/discussed:

- 1. All ITF manuals will become available on eBooks at US\$9,99.
- 2. They are considering to allowing countries to print manuals locally in order to cut costs. With declining Rand and courier costs, the average price of a manual has almost doubled.
- 3. The first online course for CPE will be available from 2016.
- 4. The TSA proposal that a set of questions at the end of each iCoach presentation be added in order for the presentation to also be used for CPE will be investigated.

The **Seniors IPT** was hosted in **Cape Town** in April 2015. It was the largest IPT hosted since 2011, with 300 players! Everyone thoroughly enjoyed the friendly, happy vibe the committee created and the venues were excellent! The Gala Dinner was hosted at Kenilworth Racecourse for 350 guests and was outstanding. Then, less than three weeks after the IPT, their second Seniors Tournament, the **2015 Cape Town Seniors**, was hosted from 8th to 11th May and once again they managed to attract a bumper entry for the past ten years and hosted a hugely successful event.

The **ranking system** approved at the last Seniors Workshop was still not implemented for this tournament as Daniel Meure in Holland refused to implement the necessary changes.

The **Eastern Province Seniors** tournament was hosted in Port Elizabeth from 29th May to the 1st June and once again had a much higher entry than previous years. The referee, Morne Gouws ran a very successful tournament considering that it was his first seniors provincial tournament!

Six Seniors teams left early in June to compete in the **Seniors World Team Championships in La Baule, France** and mostly finished around halfway in the final standings! Considering that we cannot practice at all on clay in South Africa, the results were very reasonable!

The **Gauteng North Seniors Tournament**, one of our flagship events, that was hosted at Groenkloof from 12th to the 16th June ran very smoothly thanks to the excellent work of the NSC Seeding Committee and our TSA Referee, Mpho Makhoba. Once again, there was a record entry.

The **Mpumalanga Seniors Tournament** held in Nelspruit is always run exceptionally well by Johann Greyling, Rouvaun Heyns and his Seniors team and the tournament this year was no exception! The tournament was run from 16th to the 19th July and the number of entries was once again the highest since 2010! The courts are excellent and the attention to detail displayed by the organising committee makes running a tournament there an absolute pleasure. The tennis was of a very high standard and

some of our top-ranked players participated. Unfortunately we had a fairly serious injury when one of the ladies fell on court and had to be hospitalised. She is recovering well after an operation. A casual braai held after tennis on the Friday evening was extremely well attended and the hospitality was superb.

The **KZN Seniors Tournament** held in Durban during August was very successfully run by Andrew Comrie, one of the stalwarts of Seniors Tennis! The entries were well up on last year and Dave Vincent and his team once again ensured that the players thoroughly enjoyed their time in KZN! The provision of food and refreshments courtside this year was extremely well received. The players also provided very positive feedback on the change of draws of 6 and 7 to double round robins with playoffs!

The **Super Seniors Inter-Provincial Tournament** held in Klerksdorp from 16th to 22nd August was rather disappointing in some respects. Firstly, the condition of the courts at the venue, Schoonspruit Tennis club was disappointing and complaints were received from a number of the players. Secondly, a number of provinces did not send any teams to compete and so the number of teams entered was smaller than expected. NWP provided excellent catering throughout the tournament and the functions were well organized. The Gatsby theme at the Gala Dinner proved to be a huge success!

The six Super Seniors teams selected to participate in the **Super Seniors World Team Championships** in Umag, Croatia from **21**st **Sept to 26**th **Sept** fly out next week! Many of them will also compete in the **Super Seniors World Individual Championships** the following week and we have two **World Champions** who are going to be defending their World Titles. **Petro Kruger**, who won two gold medals for winning the 70+ women's doubles and 70+ mixed doubles last year with fellow South African Kobus de la Port and a bronze medal for coming fourth in the 70+ women's singles and then **Jackie Zylstra** who won a gold medal for winning the 80+ women's doubles. They will both be receiving the traditional R2,000.00 contribution from the NSC towards their expenses to go and defend their titles!

The **Boland Seniors** and **North West Province Seniors** tournaments were once again run concurrently from 24th to the 27th August. The number of entries for both tournaments was up on last year. The one concern in NWP is the condition of some of the courts at Schoonspruit Tennis Centre, so alternative venues may need to be considered.

The **Young Seniors Inter-Provincial** was hosted by **Gauteng East** from **11**th **to 17**th **October.** Owen O' Neill, Chairman of GE Seniors really raised the bar and treated the players to a wonderful week of great tennis and hugely successful functions. **Compliments were received** from all quarters about the venues used as well as the entertainment provided. Johann Greyling and I ran the actual tournament together and have now got the processes and procedures fine-tuned after running a number of Seniors IPTs together. Johann is a huge asset to Seniors Tennis. Unfortunately the plans for him to qualify as a white badge referee before the 2017 Young Seniors World Championships being held in South Africa fell apart as the course was cancelled by the ITF.

The **Free State Seniors** tournament due to be held from **22**nd **to 25**th **October** had to be cancelled due to the small number of entries. The **timing** of this tournament was not ideal and has been changed for 2016 to August instead.

The **2015 National Seniors Workshop** was held earlier this year on **31**st **October** at Roedean School and was well-attended by Seniors Chairmen or their representatives from all the provinces. A **cocktail party** was held at the Sunnyside Hotel for all the delegates the evening before the workshop and was a perfect

way for everyone to get re-acquainted and exchange ideas. It was an extremely productive workshop, at which all the Chairmen presented **Provincial Reports** on the status of Seniors Tennis in their provinces. All the **planning** was done and **rule changes** finalized for **2016.** A **Memorandum of Operation for Seniors** was presented by Ronnie and approved by the delegates. **Ronnie van 't Hof** was elected as **Chairman of the NSC and Seniors Board Representative.** The **NSC members** for 2016 were also elected as per the **Memorandum of Operation. Nelene Gold,** Chairperson of WP Seniors, was confirmed as the task leader for hosting the **Young Seniors World Championships** to be held in Cape Town in **2017.** Jacques Pretorius did a brief presentation on **Cardio Tennis** for the delegates and **Ephraim Motsiane** outlined the progress around implementing the new software programme from **Sporty HQ** as best he could. Details around the implementation of Sporty HQ software remained unclear and an area of concern.

The PSC understandably expressed their concerns about the non-implementation of the ranking system as approved by them at the previous workshop. Ronnie van 't Hof and Andrew Comrie were given the mandate to pursue the implementation of a ranking system through Rob Kruger in Cape Town, in view of the fact that Andrew Comrie, who has a Masters Degree in Statistics, was able to produce the correct ranking for the NSC within a few days by adapting his own laptop application programme! The correct ranking was then used by the NSC to select the Young Seniors going to Croatia in 2016. Ronnie and Andrew met Rob Kruger in Cape Town and within 5 days an up-to-date ranking system was produced by Rob and visible on the iTennis website. This ranking system will now be used by Seniors for seedings and selections for the time being.

Support was expressed by the delegates for the possible re-introducton of the **Seniors Annual Subscription Fees**, which would go a long way to bridge the losses incurred on an annual basis. The proposed increases in tournament **fees for 2016** were approved: **R425** for **Nationals** and the **ITF tournament in Gauteng Central**, and **R375** for all other ranking tournaments. The proposed fees for **Inter-provincials** will be **R700** (R550 paid by the players and R150 paid by the Provinces.

The GC ITF Seniors Tournament was held at Ellis Park from 11th to 15th November. The ITF kindly granted our request to upgrade the tournament from a Grade 5 to a Grade 3 tournament! The tournament attracted all the strongest players from around the country who were keen to earn the International Ranking points and was very successfully hosted by Russell Schluter, the GC Seniors Chairman and his Committee. Running an ITF tournament still poses a great deal of extra work for both myself and the White Badge Referee, who in this case was Mpho Makhoba, who did a great job. Ellis Park as a venue was extremely disappointing as it is in a shocking state of disrepair and urgently requires some attention. The courts are fine but the piles of rubbish and the state of the nets and lights were a source of embarrassment to GC players. There are also very precious tennis memoirs which reflect a rich history of tennis at Ellis Park stored haplessly at the back of the Art Gallery which should really be rescued and preserved.

Eden Seniors Tournament entries for December exceeded those of last year. Seniors tennis tournaments **recorded record entries** in 2015/2016 season.

The Western Province Committee hosted the WP Seniors Tournament from 15th to 18th January at Rondebosch, and Kelvin Grove. Nelene Gold, the new WP Seniors Chairperson and her committee ran an excellent tournament. The plan was to run SportyHQ and Tournament Planner parallel for this tournament in order to test it out and train Andrew Comrie and myself, but there were still way too many gaps in the programme which prevented this from being possible.

The Gauteng East Seniors Tournament was held at Benoni Tennis Centre and Parkrand Tennis Club over two weekends starting on 22nd January. Owen O'Neill, Chairman of GE and his dedicated committee hosted an outstanding tournament. The atmosphere was very friendly and welcoming and the attention to detail given to ensuring that the players had everything at their fingertips was excellent. Jan de Graad did do some training at the tournament, but it was still not possible to run the tournament on SportyHQ.

The **West Rand Seniors Tournament** was held again this year with a fairly small entry. It was held at the German Country Club this year as the West Rand Clubs are becoming more and more reluctant to allow us the use of their facilities. It was extremely disappointing that the cost of the balls was suddenly raised substantially by the suppliers just before this tournament which really hurt the province financially. The price change is usually only in April, so this was a financial shock for both the GC Committee and myself as Nationals is normally our last tournament before the price increase. The tournament was run on Tournament Planner and it was decided to delay the switchover to SportyHQ until after the Nationals to avoid any problems occurring at such an important Seniors event.

The **SA Nationals ITF Seniors Tournament (Closed)** was held in Bloemfontein from 5th to 9th March 2016. There were **299** participants. Jan de Graad was there to help some of the Seniors register on SportyHQ. Kloppers again very kindly sponsored each of the players with a R100 voucher and Dunlop eventually sponsored two tennis racquets and 2 boxes of balls. The towels we had made as handouts were very popular with the players. A very high standard of tennis was displayed and the tournament was run very efficiently by our two Referees, Johann Greyling and Andrew Comrie on the League Planner. It was hugely disappointing that many players did not attend the function and this cost us as we were forced to forecast a number well before the time. This will be discussed at the Workshop in October.

The selection of teams from the **50-60+ age groups** to compete in the **Seniors World Team Championships** in Helsinki, Finland took place the week after Nationals. The players were informed and the names published.

The guaranteed strength **Ranking System** approved for **2015** at the Seniors Workshop in November 2014 is now planned to be implemented in May in time for the **Eastern Province Tournament** in early June. The rules have been adjusted to ensure that there are clear directives with regard to allocating points so that there are no discrepancies in how the points should be allocated both in Monrad and Round Robin events. The current **iTennis** ranking system will remain in effect in the meantime.

The switchover to **SportyHQ** for online entries was done when the **Cape Town Seniors Tournament** was opened for entries. The Senior players were informed before, during and after the changeover and sent links to activate their profiles and register. The loading and entry process proved to be a challenge as there were certain functions still missing or not yet correctly set up for Seniors, which made for a great deal of manual input from myself and my tournament referee.

The six **35–45+ Young Seniors** teams chosen to represent TSA Seniors in **Croatia** from 1st to 6th May left to compete in the **2016 ITF Young Seniors World Team Championships** from 1st to 6th May 2016. Our teams didn't win any medals in the team championships, but in the Individual Championships our 45+ mixed players from KZN, Lettica Venter and Bruce Young won **the event and received gold medals! Bruce Young and Robert Dick** also reached the semifinals of the MD45 and received bronze medals. **Lettica Venter** reached the quarterfinals of the WS45.

The **World Team Championships** will definitely be held in Cape Town in April 2017. Ronnie van 't Hof is liaising with the WP Senior Committee in this regard as they will be hosting this event in conjunction with the Boland Seniors. Ronnie will liaise with Iain Smith with regard to the officiating needs for this event. The Young Seniors who went to Croatia in May handed out flyers advertising our 2017 event.

This first quarter of 2016 was very challenging in light of the SportyHQ changeover, the very full programme and the huge demands placed on staff members. The delayed payments to players, officials and provincial bodies remains an area of concern.

The National Seniors Committee, the Provincials Seniors Committees, the Referees involved in Seniors tennis and the numerous volunteers throughout the country, continue to contribute to the success of Seniors tennis and have been unwavering in their support as we have grappled with software, ranking and financial challenges during the past year.

In Summary:

- Seniors is thriving and the numbers are healthy.
- Recorded record entries during the 2015/2016 season.
- Challenges have been the changeover to SportyHq and the maintenance of Seniors Ranking.
- Our players have won a number of titles in the World Individual Championships.
- Our bid to host the Young Seniors World Championships in South Africa in 2017 was successful.

11 WHEELCHAIR TENNIS



WTSA aims to make South Africa one of the leading Wheelchair Tennis Nations in the world, and is working hard to break the barriers of disability, making the sport and our players household names and heroes.

We believe our programmes and achievements in 2015 have taken us one step closer to achieving these goals.

DEVELOPMENT

Wheelchair Tennis has a Development Officer and a Community Camp & Programme Manager to oversee and run the development programme and to fast track the progress of those players with ambition, ability and drive.

The main aims of the development programme remain:

- to ensure the active centres are functioning optimally
- to fast track the development of the players showing potential

We are now proud to say we now have over 50 centres, serving 500 plus players, and function in **all provinces**. We however acknowledge that in some we have only scratched the tip of the iceberg.

For us, it is not only about the number of centres, but it is important for us that the centres are **functioning optimally and the players and coaches are improving**. The centres are therefore monitored regularly, and a clinic//competition is run in each region about 3 times / year. These events are aimed at players from beginner to advanced beginner level. They introduce players to competition, provide a clear pathway for those wanting to climb the ladder, and for those showing potential and performing well, the opportunity to compete against others at national events.

This programme has helped us to produce players such as Lucas Sithole, Evans Maripa and Kgothatso Montjane, all of whom are in the top 16 players in the world. We are also working hard on producing the next generation of SA stars, which include Bongani Dlamini and Danny Mohlamonyane in the quads, Leon Els, in the men and Marika Venter, and Thando Hlatshwayo in the ladies. All of whom have the potential and are close to qualifying for the 2016 Paralympics.

We have also started work on the 2020 and 2024 athletes including our up and coming juniors, Alwande Skhosana and Mpho Mhlongu who are in the top 10 junior boys in the world, and Nokwande Hlongwane who is world no 2 on the junior girls ranking.

PERFORMANCE PROGRAMME

The performance programme is aimed at the top level player, and producing a wheelchair Tennis superstar within the next Paralympic cycle.

We hosted three International Future Level events, a Grade III, Grade I and a Super Series level event within South Africa in 2015. The Future level events cater for the players coming out of the national programmes and allow them to gain entry onto the international tour, while the Grade 1 and Super Series level event are aimed at players who are doing well internationally (top 60 in the world). A Super Series level event is the highest grade event available on the international wheelchair tennis circuit, and the ITF only approve 6 globally per year. There are also only 11-13 Grade 1 events held on the tour globally each year.

The international tournaments we host here cater for around 80-120 participants in each event, with the majority of players being from South Africa. By hosting events locally we enable many more of our players to acquire and improve their world ranking than if we handpicked the cream of the crop and only sent them abroad to participate. As a result SA now has over 60 players on the international ranking, more than any other country besides Japan. This also allows us the best opportunity to pick players with potential and fast track their development.

Besides the impressive number of people listed on the ranking, we are also starting to produce players that are breaking into the top levels internationally. This is very impressive as our players have only been playing wheelchair Tennis for around 9-10 years at most, where the top players internationally have been fully professional for far longer than that. This highlights the great pool of talent we have and that the opportunity exists to really produce a superstar for SA in a relatively short space of time.

Players to watch out for:

WOMEN:

Kgothatso Montjane – SA's No 1 ranked women, currently ranked 8 in the world, and has a personal best World Ranking of 5 (2013).

Mariska Venter - SA's no 2 ranked women, currently ranked 31 in the world, with a personal best ranking of 27 in 2014. Mariska also ended 2013 as the no 1 junior girl in the world.

Thando Hlatshwayo - SA's no 3 ranked women, currently ranked 52 in the world, with a personal best ranking of 36 in 2014. Thando was also ranked as high as the world no 2 junior girl in 2014.

MEN:

Evans Maripa – SA's No 1 Man, currently 16 in the World, with a personal best ranking of 11 (2015) **Leon Els** - SA's No 2 ranked man, currently ranked 37 in the world, with a personal best ranking of 29 in the world (2016).

QUADS:

Lucas Sithole – SA's No 1 Quad, currently ranked 3 in the world, personal best ranking of 2 (2014). Lucas also won the US Open Grand Slam quads singles title in 2013, as well as the British Open. He was quads singles and doubles runner up at the Australian Open 2014, and Quads doubles winner at the Australian Open in 2015. .

Bongani Dlamini – SA's No 2 Quad player, currently ranked no 26 in the World personal best ranking of 14 (2015).

Danny Monhamonyane – SA's No 3 Quads player, currently ranked no 30 in the world, and has a personal best ranking of 27 in the world in 2016.

JUNIORS:

Alwande Skoshana— SA's No 1 ranked junior boy, who at 15 years of age is ranked no 3 on the world junior boys ranking (under 18)

Mpho Mhlongu - SA's no 2 ranked junior boy, is currently ranked no 11 in the world, with a career best ranking of 11 in the world (2016)

Nokwande Hlongwane - SA's no 1 ranked junior girl is also 15 years old, and is ranked no 2 on the world junior girls' rankings (under 18). Her career high ranking thus far is world no 2 (2016)

Asive Gilifile – SA's no 2 ranked junior girl, and is ranked no 7 in the world on the junior girls ranking.

SKILLS DEVELOPMENT

Coaches Education: We have tried to include continued coaching education modules at each of the national camps we hold. In this way we hope to grow the coaches along with the players they are coaching.

SUCCESSES IN 2015

WTSA is very proud of the following achievements in 2015

- Have players ranked in the top 16 players in the world across 5 divisions Men,
- Women's, Quads, Junior Girls, Junior Boys
- Have 60 plus players on the world ranking ,second only to Japan
- Had players represent us at the Australian, French & Australian Open Grand Slam events
- Lucas Sithole won the quads doubles event at the Australian Open 2015.
- Lucas Sithole & Kgothatso Montjane were invited to compete in the world singles
- Masters, in 2013, 2014, 2015
- 2 Juniors were invited to participate in the World Junior Masters Alwande Skhosana and Nokwanda Hlongwane
- Evans Maripa was one of 8 teams to play in the World Doubles Masters on 2014, 2015.
- WTSA had 2 coaches on the ITF Global Wheelchair Tennis Coaches Commission
- WTSA hosted 6 international events in South Africa, one of which was a Super Series (one of the top 6 events on the world wheelchair tennis tour)
- Hosted 30 plus regional camps & 2 National Camps
- Hosted the John Cruyff Africa Junior Camp an ITF development camp for promising players in Africa
- Has an active development programmme in all provinces, with activity in 50 plus schools and centres.
- Kgothatso Montjane, Lucas Sithole, Karen Losch, and Holger Losch were nominated as SA's best
 Sportsman / woman with a disability, best administrator and coach of the year in 2015. Lucas Sithole
 was also nominated for People's Choice Best Sportsman in SA in 2015, and Nokwanda Hlongane
 was nominated in the category of Newcomer of the Year. All where finalists, with Lucas winning
 Sportsman of the Year with a Disability.
- Nokwanda Hlongwane was nominated for Up and Coming Sportswomen of the Year at the Spar G Sport Awards 2015, and won Gauteng School Sports Newcomer of the Year category.
- Lucas Sithole and Kgothatso Montjane were nominated for Gauteng's Sportsman / Woman of the Year with a Disability 2015, with KG winning that award.
- WTSA won the Letsema Award, which is given to a Disabled Sport, for a promising programme, and a programme murray & Roberts feels will make a difference to individuals.

CHALLENGES IN 2015

- Ensuring quality grassroots programmes run in Metropolitan areas such as Cape Town and KZN continued to be a challenge
- Funding is a major challenge as we are growing faster than our current funding allows
- Realignment and restructuring of governmental sporting priorities has impacted on the amount of funding available
- Ensuring the up and coming players, as well as players on the cusp of Paralympic qualification are provided with sufficient opportunities to compete.

GOALS FOR 2016

We aim to continue to improve the quality of the grassroots programme, to upskill our coaches, offer players as many competitive opportunities as possible, and prepare our top players for the 2016 Paralympics.

12 PROSPECTS FOR 2016/17

I have alluded to the financial challenges facing Tennis South Africa in my introduction. The Board of Tennis South Africa is continually assessing and evaluating opportunities to improve revenues. Whilst we acknowledge the grant with appreciation from the Department of Sport and Recreation, this is meant to assist, not run the Federation financially.

The Board of Tennis South Africa will continue on its strategy of:-

- reassessing what its stakeholders want and need against the cost of providing such services;
- changing tournaments into events that result in an income;
- carefully assessing the overhead structure to ensure operations run at maximum efficiencies;
- actively seeking sponsorships with potential stakeholders who wish to see the game of tennis prosper at all levels.

We actively continue the pursuit of holding ten to fifteen weeks of International Tennis Federation Futures Events in our country a year. We acknowledge the significant contribution of the Cylix Group in their committed three weeks of Futures this coming year and next.

Simultaneously with the finalization of this Annual Report is the announcement that we have appointed a Chief Executive Officer, Mr Richard Glover. Mr Glover joins us bringing a wealth of experience in the commercialization of a number of sport types and equally important, a number of sponsorship opportunities which should hopefully significantly change both our financial position and resultantly our ability to deliver to our stakeholders.

Riad Davids and I attended the International Tennis Federation's 2016 Annual General Meeting in Croatia in June this year. We both agree that there are "winds of change" blowing through the corridors of our mother body – not only in terms of a "changing of the guard" with regard to personal, but also with regard to being inclusive, treating people with respect, conducting business with integrity and focusing on the development of the game at grass roots level.

I have the privilege of serving on the Non-World Group Davis/Fed Cup Commission that is looking at the structure of both competitions. The goal is to "refresh" the world's largest sporting competition, make it both more spectator friendly and accessible, and most importantly improve the revenue generation in such a manner as to obviate home nations being faced with an ever increasing financial burden.

I am hopeful that we will finalize our Constitution during the forthcoming year – I know I said this last year. However delays in the main have been occasioned by SASCOC, from whom we are still waiting on final approval of our proposed draft. That said, we propose to revisit this draft document as it may well be that the proposed Constitution may not best serve our needs in terms of structure. To this end the Board's Constitutional Committee will look to co-opt a number of Provincial Representatives and carefully look at the options going forward. As I said last year, our Constitution will have certain non-negotiables:-

- be compliant with the Companies Act of 2008;
- Adhere to all the recommendations of King IV;

- Adhere to the Constitution of South Africa;
- Adhere to the requirements of SASCOC.

Inherent in the above and notable likely changes to our current Constitution will be:-

- A Board Member representing the professional players;
- A Board Member representing Technical Officials;
- A rotational Board Election process where a third of the Board is elected each year (as opposed to the current election process that takes place only every three years);
- The right of the National Federation to intervene in the affairs of under-performing provinces.

As I have mentioned, it is our intention to increase the participation of provincial representation on a number of our Board sub-committees. Too long, in my opinion, has there been a "disconnect" between Tennis South Africa and its affiliates. Tennis South Africa will follow the International Tennis Federation's model of asking suitably qualified and identified Provincial Representatives to serve on relevant Committees and taskforces. We all need to take responsibility for our game.

Transformation and development in our game is a non-negotiable. Tennis South Africa is firmly committed to both. SRSA and SASCOC have implemented a score-card process that rates and measures the various Federations' performance. You will all have contributed in some way to the EPG Report that we had to submit by the end of June 2016. The next report has to be submitted by the 31 March 2017. I appeal to all of you to assist the office, when requested. Future funding and sanctioning of National Teams and International Events are at stake!

The 2016/17 has been and is busy to date. We have hosted a home Davis Cup Tie against Luxembourg (which we won convincingly), our Fed Cup Ladies team, who were unfortunately relegated earlier this year, will again play in February 2017. We have at least three Futures Events lined up over the next eighteen months (with the distinct possibility of another six) and a host of the normal ITF Junior, Super 7's, Seniors, and Masters Events on a full calendar. We thus strive towards creating the right environment for tennis to prosper. I urge all players to participate and support us in our desire to becoming a "leading Tennis Winning Nation".

13 CONCLUSION

The current Board of Directors term of office ends today. Each member has contributed willingly and without expectation of reward for their services as directors of the company. We collectively have endeavored to listen, watch, engage, question, challenge, lead and above all learn.

I take this opportunity of thanking my Board colleagues for their time, wisdom and support. I also thank members of Council for their patience and support. I would be amiss not to thank all those many volunteers around South Africa who give of their time without any expectation of remuneration or recognition who make tennis happen. My appreciation to each and every one of you.

The next twelve months will be exciting and I sincerely believe that when I present next year's report, our position and standing will be significantly improved.
