Good Evening Perris Union High School District Families,

Thank you for your patience and willingness to support your students at home during this unprecedented time. The purpose of this communication is to share the instructional plan that students will receive as we transition to distance learning. As a district, our goal is to provide ongoing learning and instruction as we all experience the everchanging effects of COVID-19. Knowing we can never replace classroom instruction with a teacher, our instructional teams are diligently working to develop learning opportunities that fosters continuous growth for our students using multiple methods. In the upcoming weeks, we will be implementing enrichment activities, credit recovery/make-up work, and distance learning opportunities in two stages:

Stage I March 23rd – April 3rd: The district has provided optional, non-graded learning and enrichment activities for students through a district resource page. Students and parents are encouraged each day to select an activity in each content area to practice skills. Teachers may also share enrichment activities to students through the use of our digital platforms (Canvas, Google Classroom, or email). Teachers will check in on a regular basis to support students and maintain ongoing communication with students and families. In addition, students will also have the opportunity to work on credit recovery and make-up assignments. Systems will be in place for students to complete courses and take tests in credit recovery through the Plato/Edmentum platform. Details on how students will complete these activities will be communicated directly with students that are currently making up courses. Families are encouraged to continue using the website for the most up to date information.

**Stage II Beginning April 13th - Tentatively April 30th:** Upon the return from spring break, students will participate in instruction through distance learning opportunities for each of their classes to the extent it is possible. Teachers will communicate with students/families on an ongoing basis to provide instruction, course expectations and supplemental resources.

**Device Pick-up / Repair:** During this time, it is imperative that our students are supplied with all the tools needed to participate in distance learning. All students should already be in possession of a fully functioning Chromebook. For PUHSD students who do not have a district Chromebook or need a repair, please follow the schedule below at your school site:
