## Location

Broadwater Down is a highly sought after residential location on the south west edge of Tunbridge Wells. The road is within a Conservation Area and is characterised by large period Victorian houses and classified as an Arcadian Area with low density development and protected landscaped frontages. Broadwater Down sits between the Eridge Road (A26), to the west, and Frant Road (A267), to the east, and with easy access on foot to the historic Pantiles & "Village Area" of Tunbridge Wells.

# **Description**

Broadwater House is detached period mansion house arranged over ground, first and second (roof) floors with some large useful basement areas, set in beautiful mature grounds of around 1 acre. The property has subsequently been converted and now comprises 5 self-contained apartments and off street parking.

There is a planning application pending for the conversion, and part demolition of parts of the existing building, together with an extension to create a total 14 apartments each with allocated parking. Planning ref - 18/02773/FULL
