4. Affiliation fees

To determine the Affiliation Fees from the members for 2016, as per the deferred resolution from the AGM.

- a. Resolution: That the 2016 Affiliation fees for members be established as per the attached Pricing Model, noting that notwithstanding the Pricing model, that the maximum affiliation fee payable by any State or Territory
- i. In 2016 will be 5% more than the average fees paid by that State or Territory in 2013, 2014 and 2015; and
- ii. In 2017 will be 10% more than the average fees paid by that State or Territory in 2013, 2014 and 2015.
- b. Resolution: That the 2016 Affiliation fees for members be established as per the rates agreed for 2015 increased by 1.5% being the All States all Categories CPI increase to September 30th 2015.

Moved by the Board.

- David Mandel requested an amendment to the resolution a, removing reference to the second year (2017) by deleting the whole of a.ii. There was a discussions around the reasons and this was unanimously agreed.
- David Mandel requested a second amendment based on the energy displayed in the meeting. It was in the case resolution A is approved that we vote on resolution B. The Board would take this forward and make the best decision from the two after the February meetings.

There was an extensive discussion around the meanings from this motion. The amendment failed: 67 in favour, 85 against and 24 abstentions.

- [Note these minutes correct the result declared in the meeting that the motion failed on 79 votes in favour.]
- Representatives from Queensland, NSW and Western Australia wanted it noted at this time that they felt the amendments were in breach of the constitution.

- Resolution A was voted on Passed; 91 for 85 against.
- There was a discussion on why Resolution b. did not require a vote. as resolution a. had passed. The intention of the second amendment was to allow the second vote, but it had failed. Without this, resolution b. was withdrawn by the Board.

4 Any Other Business

- Dawn Moggach raised a concern in regards a change in financial policy which meant volunteers would be paid their expenses after the expense had occurred not before. David Mandel explained this was to help ease administration within the office due to the numbers of events' cancellations and illnesses which meant monies were needed to be returned to the office. He noted that this policy applied to all people whom were reimbursed expenses, being players, coaches, staff, board members, volunteers and referees.

David explained with the use of credit card in the modern day, that this should not be an issue with prompt payment within 30 days.

If there were exceptional circumstances then the office would look at these on a case by case basis.
