Minutes of Committee Meeting held on Saturday 17th August 2013 and Sunday 25th August Eastside Squash Centre, via Skype and telephone

2. APOLOGIES

There were no apologies.

3. PRESENTATION ON SQUASH DEVELOPMENT COUNCIL OUTCOMES

Max Moorhouse addressed the Committee on the Australian Junior Squash Tour, delivery of Oz Squash as an Active After School Communities Program and the new Squash Australia Coach Classifications. Documentation attached to these minutes summarises the material presented.

4. TREASURER'S REPORT

The Treasurer's report was circulated with the Agenda prior to the meeting. An amended report was forwarded via email Saturday morning, 17th August. It was moved Mark Noonan, seconded Julie Smith-Kingston "that the Treasurer's Report be received and that the Treasurer be requested to continue to follow up outstanding invoices".

5. CONFIRMATION OF MINUTES OF PREVIOUS MEETING

It was moved Greg Ward, seconded Kent Harbutt "that the minutes of the meeting held on Saturday 8th June, 2013 be confirmed.

6. BUSINESS ARISING FROM THE MINUTES

To be reviewed by Chris Doig and a list of outstanding items to be forwarded to the Committee for action.

Brett McGrath has accepted the role on Minutes Secretary and will prepare the Agenda for the next meeting and the Minutes with the assistance of Chris Doig. He will take over the full role starting from the subsequent meeting.

7. GENERAL BUSINESS

7.1. Operational Plan Mid-Year Report

The Manager, Tasmanian Squash Academy spoke to his report on the Squash Tasmania Operational Plan. He advised that the second paragraph of the discussion was incorrect and that the percentage of the expected income from affiliation fees was similar to 2012.

It was moved Chris Doig and seconded Leon Barnett

- 1. The report be received and the contents noted.
- 2. The Squash Tasmania Performance Pathway Committee be requested to provide a report on the program including a detailed financial report including all income and expenditure."

7.2. Appointment of Service Provider for Squash Tasmania Administration and Program Delivery

Following discussion which resulted in the motion being amended to delete reference to the "Development Manager Position Description", it was also resolved that there should be a face to face meeting held to discuss the 2014 Operational Plan. This would include a discussion on the relationship between the Totball and Squash-in-School Promotions, Oz Squash AASC delivery and other junior squash programs. It was agreed that the cost of such a meeting would be borne by individual Committee Members.

"That the report from the Squash Tasmania President on the Appointment of Service Provider for Squash Tasmania Administration and Program Delivery be received and that:

- 1. The Tasmanian Squash Academy appointed as the service provider to administer and deliver the projects identified in the Operational Plan.
- 2. The position description for the role be reviewed by the working group established at the 8th June, 2013 Squash Tasmania Committee Meeting."

7.3. Australian Junior Squash Tour Tournament Administration

It was moved Leon Barnett and Seconded Greg Ward

"That the report from the Tasmanian Squash Academy on the Australian Junior Squash Tour Tasmanian Tournament Administration be received and that:

1. The Squash Tasmania Performance Pathway Junior Committee be requested to review the considerations and suggestions in this report and to prepare a report in conjunction with the Manager of the Tasmanian Squash Academy with recommendations for Squash Tasmania's involvement in the Tasmanian Australian Junior Squash Tour Events in 2014 and beyond."

8. OTHER BUSINESS

8.1. Committee Protocols

The President addressed the Committee on protocols for processing agenda items and expressed a view that the Committee needs to project a positive image to the squash community.

8.2. President's Council Meeting, Brisbane weekend of the 9/8/2013

Kent Harbutt, Squash Tasmania's Vice President and representative on the President's Council presented a report to the meeting. It was moved Mark Noonan and Seconded Michael Brown

"That the Report from the Vice President be received and the contents noted."

8.3. Ulverstone Affiliation

The non compliance of the Ulverstone Squash Club with the Squash Tasmania Affiliation Policy was discussed. Despite many verbal requests from the President both last year and this year there has been no adequate response or payment.

Brianna Stone, a junior player from the Ulverstone Club has been selected in the State team but has not been affiliated with the club. It was decided that Brianna would be affiliated with the Tasmanian Squash Academy Ulverstone program as an interim measure. This will allow her to represent the state.

After considerable discussion it was decided that the Treasurer and the President would draft a letter to the club. The letter is to require acknowledgement by the club within 7 days and a full response within 30 days. The letter is to be hand delivered.

8.4. Outstanding Affiliation Fees to Squash Tasmania

A report prepared by Leon Barnet was not considered due to the lack of a Seconder. However, there was some more general discussion on the matter. An outstanding invoice to the Tasmanian Squash Academy was the major discussion item. It was agreed that the Treasurer would continue to monitor and discuss payments with the Tasmania Squash Academy.

8.5. Tasmanian Open

It was agreed to list this on the next agenda.
