The Assistant Dean for Development and Alumni Relations for the College of Science and Technology (CST) will create and drive the strategy as well as lead and manage the staff and operations for fundraising and alumni relations for the college. Additionally, the Assistant Dean will cultivate and manage relationships with current and prospective donors, including identifying, cultivating, soliciting, and stewarding those with capacity for gifts of \$100,000 and higher.

The Assistant Dean will work closely with Institutional Advancement central operations to leverage the resources available to increase the dollars and donor base for the unit. Serving as a liaison between both, the Assistant Dean will align unit-based priorities with those of institutional leadership. The Assistant Dean will serve on the Dean's administrative leadership team and will create and implement strategies designed to support the funding of the Dean's priorities. The Assistant Dean will collaborate with senior staff and faculty in the college as well as other colleagues throughout Temple University.

Temple University is a national center of excellence in teaching and research with an international presence. Temple's talented faculty and its broad curriculum of over 300 academic programs provide superior educational opportunities for academically talented and highly motivated students without regard to their status or station in life. Temple's richly diverse student population and the dramatic growth of Temple's residential campus community of student scholars enrich the educational and extracurricular life of all Temple's people. Temple prepares the largest body of practitioners in Pennsylvania and is among the nation's largest educators in the combined fields of medicine, dentistry, pharmacy, podiatry, and law. Temple offers more than four dozen doctoral and more than 100 master's degree programs that contribute to research and scholarship.

The College of Science and Technology, with more than 4,000 students, is one of Temple University's fastest growing schools. At CST, students work side-by-side with experienced faculty researchers in the lab, in the field and in the classroom. Since 2007, external funding for advanced research has more than doubled, creating new opportunities for CST faculty to take on today's toughest scientific challenges. CST offers more than 30 high-tech majors and a growing number of advanced degree options. The college's new Science Education and Research Center is one of the most advanced facilities of its kind on the East Coast.

### **PRINCIPAL OPPORTUNITIES**

The Development and Alumni Relations team at the College of Science and Technology has recently been restructured, including the addition of a Major Gift Officer and an Associate Director. As a result, the Assistant Dean will be able to create the strategic vision and drive the performance and results of the team. Additionally, the infrastructure in CST is in place to allow the fundraising team to truly focus on external work and increase fundraising success rather than having to also balance event planning and communications.

In the past one and a half years, Temple University underwent a wealth screening that resulted in the identification of over 4,500 CST prospects capable of making a major gift. There is a great deal of opportunity and potential, and the Dean and Senior Associate Dean of CST are positioned to be available to facilitate the fostering of relationships and the closing of gifts.

The CST Development and Alumni Relations team is a member of the 160-person Institutional Advancement team. There are a variety of resources available, including annual giving, regional giving, principal giving, planned giving, research, data analytics, and more that can be leveraged to generate great success. Additionally Temple University offers opportunities for professional skill development and career progression.

### **PRIMARY RESPONSIBILITIES**

The Assistant Dean for Development and Alumni Relations, College of Science and Technology will

- develop and manage a high-performing development program with measurable, aggressive, and attainable fundraising and programmatic goals in support of established priorities;
- be a successful advancement professional in a complex, sophisticated institutional advancement operation;
- manage a portfolio of 125-175 major and principal gift prospects, with the goal of cultivating, soliciting, closing, and stewarding leadership level commitments of \$100,000 or more;
- effectively articulate and persuasively promote the mission and vision of CST and Temple University in the context of securing private support from its various constituencies;
- leverage resources available both centrally and within CST to most effectively engage prospective or current donors, including other frontline fundraising staff and faculty, the central service operations of regional giving, annual giving, gift planning, corporate and foundation relations, prospect research, data analytics, gift processing and records, and alumni relations;
- effectively collaborate with the Director of Events and Director of Communications within CST to create and implement strategic communications and engagement opportunities for alumni and donors;
- advise the dean, Senior Associate Dean, and Institutional Advancement leadership on all matters related to development activities within CST;
- serve as the administrative liaison to the College of Science and Technology's Board of Visitors; and
- commit to the success of Temple and CST's mission and vision and high standards of achievement.

### **KEY COLLEAGUES**



## Michael L. Klein, FRS Dean and Laura H. Carnell Professor of Science

Michael L. Klein received his Ph.D. in Chemistry from the University of Bristol, UK. After holding post-doctoral positions in Italy, the UK, and the US, he joined the staff of National Research Council of Canada in 1968. In 1987 he moved to the University of Pennsylvania as Professor of Chemistry. He became Director of the Laboratory for Research on the Structure of Matter in 1993. In 2009, Professor Klein joined Temple as a Laura H. Carnell Professor of Science and the Director of the Institute for Computational Molecular Science. He was appointed Dean of the College of Science and Technology at Temple in 2013.

Professor Klein is a member of the National Academy of Sciences (2009), a Fellow of the Royal Society of London (2003), and an Honorary Fellow of Trinity College in Cambridge, UK (2013). His NAS election citation states: "Klein has advanced the frontiers of computer simulation for condensed phase molecular systems. His research has influenced the interpretation of experiments on the structural and dynamical behavior of disordered crystals, hydrogen bonded liquids, conducting fluids, supercooled liquids, self-assembled monolayers, and lipid bilayers."



Robert Levis, Ph.D.
Senior Associate Dean, College of Science and Technology

Robert J. Levis, Ph.D., a pioneer in laser-based chemistry, adaptive photonics, and biophotonics, joined the faculty at Temple University in 2002.

The Levis Laboratory focuses on understanding the photochemistry and photophysics of molecules interacting with ultrafast, ultra-intense laser pulses. The Laboratory investigates laser vaporization of condensed phase systems, laser filamentation, laser generation of nanomaterials, and the control of chemical reactions using shaped laser

pulses. These efforts are leading to new ways to diagnose disease, map cellular components, detect improvised explosive devices, classify tissues and phenotype, classify explosives for forensics analysis, and to synthesize monodispersed nanomaterials.

Prior to joining Temple, Dr. Levis collaborated with Herschel Rabitz of Princeton University to develop adaptive control of chemical reactivity, one example of the new field of adaptive photonics. Among the areas in which Levis and his group have attempted to apply adaptive photonics are biological and chemical threat agent detection.

Dr. Levis is a recipient of the National Science Foundation Young Investigator Award, National Institutes of Health Research Career Development Award, Camille Dreyfus Teacher-Scholar Award and is an Alfred P. Sloan Research Fellow as well as a Fellow, American Physical Society.

Dr. Levis earned his bachelor's degree in chemistry from LaSalle University in 1984 and his doctorate in chemistry from The Pennsylvania State University in 1988.



Jim Cawley
Vice President of Institutional Advancement

Jim Cawley is Temple University's Vice President of Institutional Advancement. As vice president, he directs the university's fundraising and alumni relations operations to ensure Temple's mission of providing affordable, accessible, diverse and high-quality education.

Cawley has been part of the Temple family for over 25 years. He graduated cum laude with a bachelor's degree in political science in 1991 and a law degree from the Beasley

School of Law in 1994. An active alumnus, he also served as a Commonwealth Trustee at Temple from 2011 until his appointment as vice president.

With a long career in the service of others, both regionally and nationally, Cawley has significant experience with fundraising, organizational advancement and addressing the needs of the surrounding community. As president and CEO of United Way of Greater Philadelphia and Southern New Jersey, he led the organization's work to improve Education, Financial Stability and Health for the region's most vulnerable populations. He oversaw UWGPSNI's mission to harness, leverage, and strategically invest the collective power of more than 100,000 donors, advocates and volunteers to drive measurable, lasting impact.

As the 32nd Lieutenant Governor of the Commonwealth of Pennsylvania Cawley honed a unique understanding of how various strategic improvements can lift the entire region. He also brought government and community leaders together through his work with various statewide commissions and partnerships. Prior to being elected to statewide office, Cawley served on the Bucks County Board of Commissioners, as Chief of Staff to State Senator Tommy Tomlinson, and as a member of the board of the Bristol Township School District.

In the community, Cawley has served on the board of directors for Lower Bucks Hospital and as trustee of Bucks County Community College. Currently, he serves on the Board of Directors for the Chamber of Commerce for Greater Philadelphia and Manor College.

Donald Kirkwood has 30 years of advancement experience in all sectors of higher education, both in the US and the UK. Currently Assistant Dean for Development and Alumni Relations at Temple University's Fox School of Business, Don previously led fundraising programs for an international school (The American School in London), liberal arts colleges (Geneva College and Albright College), medium-size universities (Roger Williams University), and professional schools (University of the Sciences in Philadelphia and London Business School). Uniquely, Kirkwood has cultivated and solicited gifts in 18 countries on 5 continents. Under his leadership, the University of the Sciences won a

CASE Excellence in Fundraising Award.

Kirkwood holds a B.A. in history from Geneva College (US) and an M.Litt. in history from the University of Edinburgh (UK).



### Ashley Lomery Assistant Vice President, Institutional Advancement

Ashley Lomery has been with Temple University since 2007. In her current role, she works on behalf of all of Temple's schools, colleges, and units to identify, qualify, cultivate, and solicit principal gift prospects nationwide.

Lomery began her career in fundraising in 1996, holding progressively responsible positions at the Autry Museum of the American West in Los Angeles, CA; Art Center College of Design in Pasadena, CA; and California College of the Arts in Oakland, CA. Ashley joined Temple as the Director of Development for the College of Public Health, and held the same title for the Klein College of Media and Communication prior to joining the central advancement team in 2011 as Executive Director of Leadership Giving. Over the course of four years, Lomery strategically built Temple's first central major gifts team. She assumed her most recent role in 2015. Lomery holds a bachelor's degree from Ithaca College, and serves on the Board of Directors for The Clay Studio, a ceramic arts and education organization in Philadelphia, PA.

A Bachelor's degree and at least five to seven years of progressively responsible higher education fundraising experience with a proven track record of closing six to seven figure gifts is required for this position. An equivalent combination of education and experience may be considered.
