<u>JOB PURPOSE STATEMENT:</u> To be responsible for a variety of functions and activities related to the preventive maintenance and repair of swimming pool equipment, and the cleaning and operation of swimming pools; and to perform routine custodial job functions.

## JOB FUNCTIONS:

- Operates, services and maintains heaters, circulating pumps and related equipment
- Brushes, skims, and vacuums swimming pool and cleans filters
- Conducts chemical tests of water and applies proper chemicals and adjusts amount to bring pool water to standards of purity and PH levels
- Drains and acid washes pool
- Maintains and repairs pumps, equipment, and machinery used in the operation of the pool
- Backwashes and cleans swimming pool water purification systems
- Keeps pool areas, walkways, and equipment clean, serviced, and safe
- Cleans dressing rooms and restrooms
- Maintains simple records pertaining to the swimming pool operation
- Reviews and monitors the swimming pool maintenance activities to ensure compliance with State and County regulations
- Knows methods, techniques, procedures, tools, equipment, and chemicals utilized in sanitizing, cleaning, and maintaining a commercial type swimming pool
- May use underwater breathing apparatus to clean and service pool
- Stores, maintains, and sets up, as necessary, aquatic athletic equipment

- Assists in reporting and preventing facility vandalism
