#### Location

The property is situated close to the A284 Arundel Relief Road on the southern outskirts of Arundel. The property is located close to Arundel Park and the Arundel Castle Cricket Ground.

Chichester, Worthing and Horsham are all easily accessible as is the south-east motorway network and rail connections are available close by at Arundel mainline railway station.

## **Description**

The property comprises a timber framed former Saw Mill. To the front there is a large yard area with a raised loading platform. The building benefits from mains water, concrete floor, fluorescent strip lighting and a three phase electricity supply.

There is a single storey self contained office with additional storage adjacent to the Mill. The premises benefit from a kitchen and WC facilities.
