SITUATION/LOCATION

The property occupies a favourable position adjacent to the Market Place in the heart of the town centre accessed via covered archway next to Rhubarb and Roses. Bedale is an affluent and popular market town with a diverse high street incorporating occupiers including Costa Coffee, Thomas the Baker, Barclays and a range of local operators including cafes/eateries, retailers and general dealers. Bedale lies approximately 2 miles south west of A1M with access at Junction 51 lying some 9 miles west of Northallerton, 21 miles south of Darlington and 37 miles north of York.

PREMISES

Two storey retail premises of traditional stone construction under a flat and felt covered roof with velux roof light.

The property is arranged to provide a vestibule entrance to sales area on the ground floor together with a further sales area and shower room, basin and wc on the first floor. The property incorporates new UPVC double glazing and is heated by way of electrically operated wall mounted heaters.

The property may suit a variety of commercial uses subject to any necessary statutory consents.
