The Vice President of Philanthropy will be responsible for the leadership, strategic direction, financial performance, and operational results of the Lifespace Foundation, overseeing all fundraising activities for the Lifespace Foundation and Lifespace Communities, which include more than 5,100 residents throughout 15 communities in eight states. The Vice President will provide leadership for the creation of strategic fund development initiatives including major and planned giving programs, annual giving, donor stewardship and recognition programs, management of volunteer leadership, public relations related to fund development, and the development of campus-based campaign strategies.

The Lifespace Foundation, established in 1992, serves as the charitable arm of Lifespace Communities, Inc. The Foundation has evolved into the multi-dimensional organization that it is today, fulfilling its mission to support the health and welfare of its residents through philanthropy. It was once believed that a senior living community should be the next best thing to being home. Lifespace Communities believes it must be more than the next best thing: It must really be home. When a resident joins a Lifespace Community, they move into a new home in a new "neighborhood." Their floor plans may change and the lawn may not need their personal attention but the feeling is still the same of being part of a community and wanting to be a good neighbor. For nearly three decades, the Lifespace Foundation has been providing tax-deductible charitable opportunities for residents, team members, family, and friends who are inspired to enhance the lives of those in these communities and to be a part of "neighbors helping neighbors" and "friends helping friends."

Through the unwavering promise of benevolent care, if a Lifespace resident outlives their financial resources, through no fault of their own, the organization will continue to support and care for that resident the remainder of their life. In addition to benevolent care, there are also funds that support the social, intellectual, spiritual, and physical needs of all residents. PRIMARY RESPONSIBILITIES

Fundraising and Public Relations

The Vice President of Philanthropy will

- cultivate relationships with residents and solicit major, planned, and annual gifts;
- develop and execute a balanced fund development program that involves residents, family of residents, board members, Lifespace team members, prospective donors from the greater community, corporations, and foundations;
- maintain a portfolio of capable prospective donors to the Foundation, including cultivating relationships with donors capable of 6- and 7-figure gifts;
- ensure the availability and promotion of appropriate outright and planned giving vehicles;
- serve as the chief spokesperson and ambassador for the Foundation's mission and goals;
- oversee and strengthen, where needed, the donor recognition and stewardship program, including appropriate awards and recognition of donors and volunteers for their support;
- oversee the timely and accurate recording of pertinent information in the development software program;
- collaborate with community Executive Directors and other leaders in the engagement of residents in philanthropic efforts;
- develop appropriate marketing, branding, and community building strategies, and assist other marketing team members in writing and editing marketing materials to attract annual, major, and planned gifts consistent with the Lifespace branding and established fundraising initiatives; and
- work to plan, develop, and implement viable, strategic capital campaigns.

Foundation Operations

The Vice President of Philanthropy will

- lead by example, embracing the Lifespace Communities' and Lifespace Foundation's vision, mission, and values;
- execute innovative ideas for raising increased funding from foundations, corporations, individuals, government agencies, and other sources;
- develop strategies to secure significant and sustainable private support to support the mission;

- ensure continual development of a robust pipeline of prospective donors;
- oversee fundraising activities to support the Lifespace Foundation's philanthropic priorities as outlined in the Case for Support;
- prepare and execute Lifespace Foundation's strategic plan with short- and long-range goals to meet Lifespace Foundation's funding objectives, and enlist support from Lifespace's President and CEO, members of the senior leadership team, Executive Directors and other local community leaders, internal and external volunteers, and volunteer groups, as appropriate;
- plan, coordinate, and execute annual campaigns related to established fundraising initiatives and seek to identify additional opportunities for philanthropic support that align with the mission and strategic objectives of Lifespace Communities;
- drive strategy and implementation of fundraising and stewardship events, as appropriate;
- manage all aspects of volunteer activities associated with fund development including volunteer identification, recruitment and training, scheduled meetings, oversight and execution of volunteer-driven activities, and related volunteer committees;
- implement and ensure adherence to established Lifespace Foundation policies, systems, and procedures;
- prepare and submit the annual Lifespace Foundation budget; and
- oversee production of the Lifespace Foundation's annual report on fundraising activities and progress.

Leadership

The Vice President of Philanthropy will

- grow the development team to support comprehensive fund development efforts in all Lifespace Communities, as well as strategic organization-wide priorities;
- provide resources to individual community leadership teams for their role as fundraisers and ambassadors of Lifespace's fundraising priorities;
- foster a positive work environment that attracts, retains, and motivates team members;
- identify appropriate training and professional development opportunities; and
- define and promote performance expectations that encourage excellence through high quality and consistent performance.

Board Relations and Development

The Vice President of Philanthropy will

- lead the preparation of materials and agenda for Foundation board meetings, retreats, and staff Foundation board meetings;
- prepare reports on the Foundations performance for the leadership team and for board of directors meetings;
- support Foundation-related board committees, councils, and community based leadership groups, collaborating with appropriate Foundation and Lifespace team members; and
- ensure proper administrative support of all board functions, orientation, evaluation, and performance metrics.

Other Responsibilities and Commitments

The Vice President of Philanthropy will

- travel extensively;
- during emergencies or natural disasters, be required to be on duty for the duration of the disaster in some cases;
- comply with applicable federal, state, and local laws, rules, and regulations, and maintain knowledge of and follow all company policies and procedures;

- obtain knowledge and demonstrate the principles of Living Lifespace, personal directed care, and successful aging philosophies, and their inherent core values of commitment, respect, compassion, dedication, teamwork, and quality; and
- support, actively participate in, and act by the principles of the Living Lifespace service culture and be familiar with and fluent in the language and service pillars of Living Lifespace.
