1. Opening and Welcome by the President.

Squash Australia President John Lee declared the meeting open at 10:06am and acknowledged the attendance of all members at the meeting, which had been called to consider a new Squash Australia Constitution.

The meeting was conducted by teleconference from the Squash Australia office, in Brisbane Queensland.

3. Apologies.

The Chairman called for apologies. The CEO advised that Life Members Margaret Zachariah, Col Clapper and Bob Finch had submitted apologies for the meeting.

The Chairman advised that in the absence of a PSCAA representative, members should not expect any action by him to censure PSCAA in accord with recent correspondence to members that he would consider doing so. Board Member Vicki Cardwell felt the comment was unnecessary and Alec MacDonald indicated that no such action could be taken as it was not listed on the agenda. The Chairman acknowledged this, but noted the matter was moot as PSCAA was not in attendance.

4. General Meeting Voting Entitlements

The Chairman referred the members to the Agenda Item 4 and the voting entitlements as listed requesting any comments or concerns. No concerns were raised.

5. Notice of Motions:

5.1. The Squash Australia Constitution 2014 Draft 3 be adopted. Moved: Squash Australia Board. The Chairman called for speakers for the motion inviting SA Director Carol Kawaljenko to speak on the Board's behalf. Further comment in support of the motion were made by Squash Vic, Squash ACT, Squash NT and NSW Squash.

The Chairman called for speakers against the motion. QSquash did so.

The Chairman also called for any further speakers who sought to make comment regarding the motion. NSW Squash did so.

Comments followed from Vicki Cardwell, Peta Murphy, Bob McComas, Alec MacDonald, Sue Shearer and the Chairman as to the of authority of delegates to represent members, process of each member to determine their position and behaviour of meeting participants.

When the meeting returned to order, the Motion was put. The Chairman resolved for convenience that members put their votes audibly in alphabetical order on a 'roll call' basis, and so;
