### **Digital Nomad Tax Checklist**

- Plan for your departure date: will you qualify for a partial year's FEIE?
- Track your travel for FEIE
- Employee? File form 673 with your employer to turn off W-2 withholding
- Self employed? Track your expenses
- Self employed? Schedule your quarterly estimated payments
- Everyone: File your tax return by deadline (April 15, or June 15 if residing abroad)
