# **FOUNDATION**

The Aspen Leadership Group is proud to partner with Kansas State University Foundation in the search for a Director of Foundation Relations.

The Director of Foundation Relations will organize and implement a development program for the targeted cultivation of foundation prospects and is responsible for executing solicitation strategies that address specific needs and areas of excellence within the university. Building and maintaining close working relationships with the department of sponsored programs and other university partners to cultivate and solicit new foundation prospects in accordance to their alignment with K-State research, academic programs and the strategic plans and needs of the University will be key to the success of the Director of Foundation Relations. The Director of Foundation Relations will lead a collaborative review of existing foundation partnerships held by K-State and the KSU Foundation working with the constituencies to identify opportunities to advance these relationships and develop the strategies to do so.

As an experienced team member, the Director of Foundation Relations will be expected to lead by example and offer assistance, mentorship, and training in best practices to new or less experienced members of the team. This position is highly collaborative with other development colleagues, and works closely with university and foundation leadership. This position also requires extensive public contact with high-level alumni, foundation contacts, and volunteers.

Kansas State University is a comprehensive, research, land-grant institution serving students and the people of Kansas, the nation, and the world. Kansas State University fosters excellent teaching, research, and service that develop a highly skilled and educated citizenry. The university is committed to the discovery of knowledge, the education of undergraduate and graduate students, and improvement in the quality of life and standard of living of those it serves.

Together with other major comprehensive universities, K-State shares responsibilities for developing human potential, expanding knowledge, enriching cultural expression, and extending its expertise to individuals, business, education, and government. These responsibilities are addressed through an array of undergraduate and graduate degree programs, research and creative activities, and outreach and public service programs. #### KANSAS STATE UNIVERSITY FOUNDATION

The Kansas State University Foundation was established in 1944 as the official fundraising organization for Kansas State University. It is a separate, independent entity chartered by the state of Kansas as a 501(c)(3) nonprofit education corporation. Gifts made to support K-State through the KSU Foundation are used according to the donor's wishes, and may not be reallocated by the state. Gifts to the foundation are tax-deductible to the full extent of the law.

Foundation staff members work in close partnership with university administrators, deans, and faculty to secure charitable contributions from individuals, corporations, and foundations to support identified priorities for the university. Gifts received through the foundation fund undergraduate and graduate student scholarships, establish faculty chairs and professorships, provide college and departmental support, and enhance the campus infrastructure.

After the money is raised, it must be prudently managed. This function is managed by foundation staff members who work under the guidance of an advisory committee of trustees.

K-State is at the threshold of a bold new vision: It will become a top 50 public research university by 2025. As a member of this elite group, K-State will be a powerful economic driver for growth and development by generating new knowledge and producing graduates who will impact Kansas, the nation, and the world. Philanthropic support from loyal alumni, friends, corporate partners, and foundations, who share a passion to see K-State advance, will be crucial to achieving this transformational goal.

#### PRIMARY RESPONSIBILITIES

The Director of Foundation Relations will

- be responsible for the initiation, promotion, execution, and evaluation of initiatives which enlist foundations to support the university through their contributions;
- build a strategy working within prospect strategy and prospect management guidelines in collaboration with other members of the comprehensive development team to advance foundation partnerships held by K-State;
- develop and implement both annual and long-range goals, objectives, and strategies to maximize support of various foundations;
- make effective use of the university's prospect management database and other institutional resources to ensure appropriate management of foundation contacts, prospects, alumni, and volunteers in coordination with university objectives and foundation's strategic planning;
- develop and implement an ongoing program of communication with foundation contacts which recognizes past and current commitments and fosters support for future efforts;
- work closely with university administration, faculty, and staff to help coordinate fundraising approaches to foundations; and
- travel throughout the United States and possibly abroad to call on current and prospective foundation contacts to solicit donations.

#### Chris Spooner

#### Associate Vice President of Universitywide Development Programs

As the Associate Vice President of Universitywide Development Programs at the Kansas State University Foundation, Chris Spooner is responsible for leading a team of fundraisers with unique philanthropic expertise that compliments the work of the Collegiate Development teams—annual giving, planned giving, corporate relations, foundation relations, and prospect qualification; and major gift staff supporting K-State Polytechnic and University Programs.

Spooner is part of the development leadership team striving to make KSUF the best development shop in higher education. Since arriving in July 2014, Spooner has

participated in the success of KSUF raising \$141.5 million in FY15, \$150.6 million in FY16 and \$152.6 million in FY17. The team achieved the initial goal of the Innovation and Inspiration campaign early and extended it to \$1.4 million by 2020.

Prior to KSU Foundation, Spooner was the Senior Associate Vice President, Corporate and Foundation Development at the University of Wyoming Foundation, where he served for more than 12 years. He managed a portfolio of current and potential donors that resulted in more than \$80 million in private and state match funds for facilities and endowments by working closely with the past and current State of Wyoming Governors, UW President, UW Foundation President, the Director of the UW School of Energy Resources and other administrators and faculty involved in energy-related disciplines.

Spooner and his wife, Dr. Kari M. Morgan, live in Manhattan and have two daughters both juniors—one in high school and the other in college.



#### John M. Morris

Senior Vice President of Development, Kansas State University Foundation John Morris joined the Kansas State University Foundation in April 2016, as the Senior Vice President of Development. Morris leads all aspects of fundraising, working with Foundation leadership, campus partners, and the KSU Foundation Board to strengthen the Foundation's overall fundraising capacity.

Morris came to the KSU Foundation from the University of Minnesota Foundation, where he served as a Senior Director of Development. At the University of Minnesota Foundation, Morris led his development team to increase their growth in gift

production by 60 percent. Prior to his position at the University of Minnesota Foundation, Morris held the position of Associate Vice President of Advancement at Benedictine University in Lisle, Illinois. Under his leadership, giving to the Athletics Department increased 300 percent, and he led the University to an all-time high in annual fundraising production.

#### Senior Director of Prospect Analytics & Research

As the Senior Director of Prospect Analytics & Research at the Kansas State University Foundation, Julie Craig leads her team in statistical analysis to identify major gift prospects and provide the framework for guiding donor strategies. Her department ensures the best prospects are visited and the optimum amount of gifts are secured by monitoring, interpreting, and sharing insights gained through statistical analysis, leading portfolio optimization for sustainable growth, using predictive models and vendor data to identify major gift prospects, calculating

philanthropic gift capacities and ensuring data is clean for performance evaluation, accurate forecasting, and long-term decision making.

In 2004, Craig joined the Kansas State University Foundation's Planned Giving Department. She moved into the collegiate development side, then to prospect management, prospect research and now prospect analytics as well. Prior experience includes real estate and banking. Craig serves as the Vice President and Secretary for APRA MO KAN. She co-chairs a subcommittee for the upcoming APRA Midwest Conference, the first joint conference with APRA Great Plains and APRA MO KAN. Craig earned her bachelor's degree in Finance from Kansas State University in 2003.

The successful candidate for the position of Director of Foundation Relations should have

- experience building cross functional, interdisciplinary, and/or intra-institutional partnerships;
- proven ability to communicate effectively and persuasively with a diverse foundation contact base, university leadership partners, foundation leadership, and peers through verbal and written means; and
- donor-centric approach with the ability to listen and translate the needs of the foundation contact into action for the university.

A bachelor's degree is required for this position as is 5 years of professional, transferrable experience in positions that have been metrics-focused, required measurable output, and relationship building or in a fundraising environment. A minimum of 3 years of development experience focused specifically on foundation relations in a non-profit, higher education or similar fundraising organization with progressive fund raising production is strongly preferred.
