#### PRIMARY RESPONSIBILITIES

The Executive Director of Major Gifts will

- develop and implement a fundraising and donor strategy that effectively moves existing and prospective individual donors, families, and family foundations from identification to solicitation;
- conduct donor discovery through research and data mining to identify, contact, solicit, and steward major gift prospects to meet measurable goals, including the development and execution of a full range of donor cultivation activities;
- build membership of NFCR's Leaders in Annual Giving Society, which recognizes donors who support the organization through gifts of \$5,000 or more;
- secure leadership level contributions of \$25,000 or more in support of the organization's mission and vision;

- work closely with senior leadership, including the CEO, to help them manage and steward their own portfolios of donors, and coordinate fundraising campaigns and events;
- develop a differentiated donor experience that fosters long-term relationships and loyalty;
- create business process standards for relationship management including the development of data management and reporting standards;
- ensure compliance with all policies and procedures related to fundraising and donor relations;
- provide direction, planning, and implementation for individual fundraising initiatives;
- develop and execute new and innovative strategies that focus on major and transformational gifts;
- manage a portfolio of donors, with specific attention to leadership level donors, including researching and identifying prospects;
- develop a differentiated donor experience that fosters long-term relationships and loyalty;
- lead, manage, and mentor a group of leadership giving officers who are responsible for cultivating and stewarding their own portfolios of donors; and
- ensure compliance with all policies and procedures related to fundraising and donor relations.

## Dr. Sujuan Ba

#### **President and Chief Executive Officer**

Dr. Sujuan Ba is the President & CEO of the National Foundation for Cancer Research, the Founder & CEO of the Asian Fund for Cancer Research, the Co-founder & CEO of the AIM-HI Accelerator Fund, the Co-Founder of the Global Coalition for Adaptive Research.

Dr. Ba has led the establishment of the Szent-Györgyi Prize for Progress in Cancer Research, an international prize recognizing outstanding scientific achievement in the war against cancer, serving continuously as co-chair of the Prize Selection Committee since 2006.

Dr. Ba also led the establishment of the AIM-HI Women's Venture Competition in 2020, a first-of-its-kind program providing lifeline seed investment, critical coaching, and valuable networking opportunities to women entrepreneurs.

Dr. Ba established the Beacon Award for Women Leaders in Oncology in 2022, recognizing outstanding women pioneers who have significantly impacted cancer patients worldwide through the development, commercialization of novel technologies and implementation of public policy.

Dr. Ba received the NBC4 WORKING 4 THE COMMUNITY Award in 2019, the inaugural *Outstanding Achievement Award* for international cooperation from Society for Neuro-Oncology of the Chinese Medical Doctor Association in 2017, and the Inaugural *CRS WOMEN IN SCIENCES Award* in 2011. She was named one of the "*Top 300 Women Leaders in Global Health*" in 2015 by the Graduate Institute of International and Development Studies' Global Health Programme.

#### PREFERRED COMPETENCIES AND QUALIFICATIONS

The National Foundation for Cancer Research seeks an Executive Director of Major Gifts with

- a commitment to the mission of the National Foundation for Cancer Research—to promote and facilitate collaboration among scientists to accelerate the pace of discovery from bench to bedside;
- an ability to successfully lead and achieve the strategic, operational, and tactical initiatives of the Foundation, and represent its mission to all stakeholders;
- depth of knowledge, skills, and abilities in fundraising, especially major gifts and leadership giving;
- an ability to manage multiple fundraising activities concurrently;
- experience managing relationships with prospective donors, cultivating current donors, and coordinating fundraising activities with colleagues across the organization;
- excellent relationship and coalition building skills and an ability to work effectively with a variety of internal and external stakeholders;
- an ability to work independently as well as on a team, and successfully set goals, communicate, and project manage;
- outstanding presentation and communication skills with an ability to serve as an outgoing spokesperson, relationship builder, and successful fundraiser;
- an ability to establish a team-oriented, collaborative work environment;
- an ability to promote a workplace culture that reflects the Foundation's values, encourages and rewards excellent performance, and promotes dedication to its mission;
- financial acumen and an ability to set clear priorities and delegate and guide investment in people and systems;
- an ability to serve as a prudent manager of organizational resources;
- knowledge of legal recordkeeping requirements for fundraising and documentation of donations;
- experience using fundraising and other relevant software;
- an ability to identify resource requirements, research funding sources, and establish strategies and approaches for successful fundraising; and
- keen analytical, organizational, and problem-solving skills which support and enable sound decision making.

The National Foundation for Cancer Research will consider candidates with a broad range of backgrounds. A bachelor's degree or an equivalent combination of education and experience and at least seven years of development experience with a focus on major gifts and leadership giving, preferably in a nonprofit organization or academic setting, is preferred.

#### **SALARY AND BENEFITS**

The National Foundation for Cancer Research offers a competitive salary and a comprehensive package of benefits, including but not limited to:

- Employer's Contribution to 401(k) plan account (without requirement of employee contribution): increase to 8% annually after 1 year.
- Both Traditional and Roth 401(k) plan available for employee participation.
- Employer pay 80% of medical and dental insurance premium and 100% of life, short-term and long-term disabilities insurance premium.
- Employer pay 100% parking fee at the office building.
- 15 days of PTO and increase to 20 days in the second year, plus 13 days of holidays.

#### **LOCATION**

The National Foundation for Cancer Research is in Rockville, Maryland. Approximately 30% of work is performed in an office environment and 70% of work is performed in the field meeting with donors. Time commitments outside of regular office hours may be frequent.

#### **APPLICATION INSTRUCTIONS**

All applications must be accompanied by a cover letter and résumé. Cover letters should be responsive to the mission of the National Foundation for Cancer Research as well as the responsibilities and qualifications presented in the prospectus.
