The Vice President, Individual Giving is responsible for developing relationships with donors who have capacity for gifts of \$1M and above; managing a portfolio of principle gift donors and prospects; and maintaining awareness of individuals in the prospect pool. This position will lead the team responsible for the solicitation of principle gifts, major gifts, grants, annual gifts, and planned gifts. The Vice President will be responsible for managing all aspects of individual fundraising and will design and implement gift strategies in alignment with priorities identified by the Senior Vice President and Chief Development Officer to meet philanthropic priorities. The Vice President will work closely with Phoenix Children's Hospital Foundation leadership to implement gift strategies that include the development of proposals, campaign materials, communication plans, stewardship, direct response programs, and other activities relating to fundraising. The Vice President will develop and implement team strategies to meet and exceed department performance standards for visits, solicitations, and gifts realized.

Phoenix Children's Hospital has provided hope, healing, and the best healthcare for children since it was established in 1983, and has grown to become one of the largest children's hospitals in the country. With a medical staff of nearly 1,000 pediatric specialists, Phoenix Children's provides inpatient, outpatient, trauma, and emergency care across more than 70 pediatric subspecialties, the most comprehensive pediatric care available in the state. The Hospital's six Centers of Excellence have grown in size and expertise to place them on par with some of the most prestigious of their kind in the United States.

To meet the needs of its growing community, Phoenix Children's continues to expand, adding new physicians, staff, programs, and facilities. Specialty and urgent care centers in high growth areas of the Valley and across the state serve the needs of patients and families in their own neighborhoods. Today, the most visible evidence of growth is a new 11-story tower on the Hospital's main campus, which offers a comprehensive, family-centered hospital that allows doctors and nurses to deliver expert care and healing to the community's youngest patients. Phoenix Children's bold vision for the future is that the Hospital will stand among the top pediatric hospitals in the nation, with a reputation for providing superior care for sick and injured children; advanced education for child health providers; and innovation, information, and influence in the field of children's health care.

The Phoenix Children's Hospital Foundation (PCHF) serves as the primary fundraising partner to the Hospital. The Foundation team is 60 people strong and will grow to more than 70 over the next 2 years. The Foundation provides needed philanthropic support for critical programs, capital projects, and a variety of services that are entirely supported by philanthropy.

### **PRINCIPAL OPPORTUNITIES**

As Phoenix Children's Hospital continues to build capacity as a world-class children's hospital, the Phoenix Children's Hospital Foundation is positioning itself for growth to accelerate this vision. In 2016, a strategic plan and reorganization was completed that targets growth from \$40M annually to \$60M by 2021. This newly created role, the Vice President, Individual Giving was developed as a part of that ambitious plan.

This opportunity is targeted to an entrepreneurial and accomplished leader who will drive a dedicated team and implement systems that will result in a vibrant and high performance individual giving program. The Vice President will be high energy and strategic, organized and systematic, and be an accountability champion with an impeccable character.

#### **PRIMARY RESPONSIBILITIES**

The Vice President, Individual Giving will

- develop and proactively maintain a robust portfolio of local and national principal and major gift prospects and donors, both individuals and family foundations, capable of contributing transformational gifts;
- provide strategic leadership to all members of the individual giving team including the recruitment, mentoring, and management of a high performance development team, and the fundraising goals of the business unit;
- facilitate the planning of gift strategies, proposal development, campaign materials, communication and marketing plans, stewardship, events, and other activities relating to fundraising;
- closely monitor and be aware of the team's portfolio progress and metrics;
- develop and implement creative strategies and timetables for the successful development and execution of all philanthropic opportunities;
- advance a culture of philanthropy and collaboration with internal and external including hospital leaders to develop, enhance, and sustain maximum fundraising effectiveness; and
- articulate the mission and fundraising goals of Phoenix Children's Hospital.

A bachelor's degree is required for this position (business/marketing preferred). A master's degree is preferred. The successful candidate will have five years of experience in non-profits, fundraising, and development. Seven years of experience is preferred.
