1. Opening and Welcome by the President.

## 5. Notice of Motions;

5.1. The Squash Australia Constitution 2014 Draft 4 be adopted. Moved: The Squash Australia Board.

The Chairman called for discussion on the motion which resulted in a motion to amend the motion whereby; 'The Squash Australia Constitution 2014 Draft 4, as amended by deleting at clause 9.2 b *'than ten per cent (10%) plus,* be adopted.'

With that, the amended motion was put and lost with 71.2% in the affirmative.

The Chairman sought clarification of the meeting had any concerns with the withdrawal of motions 5.2 and 5.3 as they were now redundant. None were expressed and so the motions were withdrawn by the Board.
