Further discussion on the use of the Squash Matrix will be listed for our next meeting.

7.1.2. Annual Squash Dinner

Chris Doig advised that Kent Harbutt was organizing this and that he had decided to hold the dinner at Eastside Squash as was the case last year. The dinner will be held on Saturday 23rd November during the City of Clarence Squash Open weekend.

7.1.3. Squash Tasmania Performance Pathway Cost Centre

Michael Brown advised that the Performance Pathway cost centre has a balance of \$6,100 but the Squash Tasmania bank account balance is much less than this. Michael is to prepare a proposal for our November planning meeting which sets guidelines for reserving cost centre funding.

7.1.4. Squash Tasmania Planning Meeting

The date and location of the meeting was discussed. The dates have previously been advised as Saturday 16th and Sunday 17th November. Chris Doig advised that he was considering Ulverstone as a venue. Leon Barnet advised that there is a meeting room at the Devonport Recreation centre that is available on weekends. Julie Smith Kingston advised that she will not be available on the Saturday. Chris Doig suggested that another representative from the club attend. This suggestion was accepted by the club. The meeting times will be Saturday afternoon and Sunday morning in order to allow travel on each day and reduce accommodation for travelling members to one night. Chris is to prepare a meeting outline and circulate to the Committee.
