### POSITIONS OPEN:

- <u>President</u> 2-year term
- <u>3 Directors at Large</u>
  - 2 of the 3 positions are for 2-year terms.
  - The 3<sup>rd</sup> is a 1-year term.
  - Specific skills for the Director at Large positions include: Accounting; Marketing; Player Development – grassroots development – adult with a focus on women; post-secondary; and doubles.

#### THE ORGANIZATION

Squash BC is a not-for-profit Provincial Sport Organization whose mission is to *"provide leadership and direction for the growth and development of the sport of squash in BC."* 

At Squash BC, we value excellence, integrity, innovation, relationships and service.

Squash BC has over 35 Member Clubs and 2,100 individual members around the province of BC.

#### THE BOARD

The Squash BC Board consists of a President, Past Director and seven (7) directors who are responsible for the oversight of Squash BC and are accountable to our members. The Board of Directors approves the Squash BC strategic plan, sets priorities for the organization, approves and monitors the budget, assesses the organization's risk profile and monitors the performance of the Squash BC Executive Director through the President.

The membership elects 50% of its directors annually for a two (2) year term at the Annual General Meeting scheduled for May 26, 2018.

#### NOMINATION PROCESS

March	Distribute expression of interest to all member clubs, viaSport, Sport BC and Squash BC e-newsletter
March - April	Interested members complete and submit a Nominations Form to the Coordinator of Member Services and Operations at <u>Office@SquashBC.com</u>
April	Personal discussions with each person who has expressed interest in becoming a director with a Nominations Committee member
April 18, 2018	Nominations close
Early May	Nominations Committee Report is circulated to member clubs approx. 21 days prior to the May 26, 2018 AGM.
May 26, 2018	If more than three directors are nominated there will be an election by private ballot. If there are three nominees, they will be declared elected by acclamation.
	If there is more than one person nominated as President, there will be an election by private ballot. If there is only one person nominated, they will be declared elected by acclamation.
