Description

An established public house with trading accommodation on the ground floor and basement and the first floor providing private living accommodation. To the side is a development plot (see Planning).

Location

The premises have a prominent position facing London Road one of the main arterial routes into St Albans from the M25. Immediately to the north is the popular Odyssey Cinema which produces considerable spin-off trade. Both the city centre and Thameslink Railway Station are within easy walking distance.

Floor Area

The approximate net internal floor area:

Basement	560 sq ft
Gross Ground Floor Area	1,625 sq ft

The first floor private accommodation comprises four bedrooms, lounge, kitchen, bathroom and office.

Planning

The public house is a locally listed building. The adjacent site was the subject of a planning application for the construction of a three storey building with basement level to create four 2 bedroom and four 1 bedroom flats (Application 5/2017/2623) which was refused. However, our client's Planning Consultant is of the opinion that the site definitely has planning potential, perhaps for a revised scheme. Further information from www.stalbans.gov.uk/planning.

Lease Terms

The public house is let by means of a full repairing and insuring lease up to November 2029. The rent is £45,000 per annum subject to five yearly reviews with the next review due on 3rd November 2019.
